**AN ACT**

Providing for the printing binding and distribution of certain extracts of fac simile pages of photo engravings of mural tablets from a publication heretofore published by the State namely Report of the Gettysburg Battlefield Memorial Commission Anno Domini one thousand nine hundred fourteen and other tablets and inscriptions contained on said memorial together with photo engraving of said memorial as completed also providing for additional matter to that heretofore published in said mentioned report being the compilation and publication of an alphabetical index of the names of all commissioned officers two thousand one hundred thirty-three in number present in the Battle of Gettysburg and a separate index of the names of thirty-two thousand one hundred forty-five enlisted men also present in said battle as the same names appear on the rosters and mural tablets of companies batteries regiments and staff

organizations now in said report of the Gettysburg Battlefield Memorial Commission and the publication of the dedication and presentation address of the late General Henry S. Huidekoper chairman of the Gettysburg Battlefield Memorial Commission transferring said memorial to the State with address of the Honorable Edwin S. Stuart Governor of the Commonwealth accepting said memorial on behalf of the State of Pennsylvania said addresses as published to be accompanied with portraits of said orators which said compilation and publication shall be entitled "Index of names of Commissioned Officers and enlisted men on the Gettysburg Battlefield Memorial as officially placed on the mural tablets and rosters of Pennsylvania soldiers present in the Battle of Gettysburg and providing for the distribution of said copies of said publication and making an appropriation for the expense thereof

2 Section 1 *Be it enacted by the Senate and House of Repre-*  
3 *sentatives of the Commonwealth of Pennsylvania in General Assembly*  
4 *met and it is hereby enacted by the authority of the same That*  
5 *the Superintendent of Public Printing of this Commonwealth*  
6 *is hereby authorized and directed to print and bind at*  
7 *the expense of the Commonwealth — copies of a vol-*  
8 *ume to be entitled "Index of names of commissioned of-*  
9 *icers and enlisted men on the Gettysburg Battlefield Mem-*  
10 *orial as officially placed on the mural tablets and rosters*  
11 *of Pennsylvania soldiers present" in the Battle of Gettys-*  
*burg The contents of said publication shall consist of the*

1 republication of all fac simile pages of photo engravings  
2 of said mural tablets erected on said memorial as here-  
3 tofore printed in the report of the Gettysburg Battlefield  
4 Memorial Commission published in the year one thousand  
5 nine hundred fourteen and other tablets and inscriptions  
6 contained on said memorial together with photo engraving  
7 of said memorial as completed also of additional matter  
8 to that heretofore published in said report namely pub-  
9 lication of an alphabetical index of the names of all  
10 commissioned officers being two thousand one hundred thirty-  
11 three in number and a separate index of the names of  
12 thirty-two thousand one hundred forty-five enlisted men also  
13 present in said battle as the same names appear on the  
14 rosters and mural tablets of companies batteries regiments  
15 and staff organizations now in said report of the Gettys-  
16 burg Battlefield Memorial Commission said publication to also  
17 contain the publication of the dedication and presentation  
18 address of the late General Henry S. Huidekoper chair-  
19 man of said commission transferring said memorial to the  
20 State with the address of Honorable Edwin S. Stuart  
21 Governor of the Commonwealth accepting said memorial on  
22 behalf of the State of Pennsylvania said addresses as  
23 published to be accompanied by portraits of said orators  
24 named

25 Section 2 The preparation of all necessary copy read-  
26 ing of all proof in the compilation of the said printed  
27 extract from said report of the Gettysburg Battlefield  
28 Memorial Commission as well as the additional work of  
29 preparing and publishing the alphabetical index of com-

1 missioned officers and the index of enlisted men shall be  
2 done by a suitable and competent person to be named  
3 by the Governor whose compensation for said work is  
4 hereby fixed not to exceed one thousand dollars

5 Section 3 The distribution of the aforesaid publication  
6 shall be as follows ——— copies for the use of the  
7 State Librarian ——— copies for the use of the Senate  
8 ——— for the use of the House of Representatives to  
9 be delivered to the members and officers of the present  
10 Legislature ——— copies to the Gettysburg Battlefield Mem-  
11 orial Commission the remainder of said copies to be  
12 placed in the hands of the State Librarian for distribu-  
13 tion by his office under proper rules and regulations to  
14 the survivors of the Battle of Gettysburg or their sons  
15 or widows to the Grand Army of the Republic and also  
16 to the Sons of Veterans and Tents of Daughters of  
17 the Civil War
