**AN ACT**

Permitting wholesale or retail dealers brewers distillers  
rectifiers compounders bottlers agents or other persons  
licensed to deal in or sell any vinous spirituous  
malt or brewed liquors to surrender licenses heretofore  
granted and issued authorizing county treasurer to re-  
fund a proportionate amount of the annual license  
fee and additional license tax requiring the State  
Treasurer and the municipalities to contribute to the  
amount so refunded and making an appropriation

1 Section 1 *Be it enacted by the Senate and House of Repre-*  
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*  
3 *met and it is hereby enacted by the authority of the same That*  
4 any wholesale or retail dealer brewer distiller rectifier com-  
5 pounder bottler agent or other person licensed under the  
6 laws of this Commonwealth to deal in or sell at whole-  
7 sale or retail any vinous spirituous malt or brewed liquors

1 or any admixture thereof who has heretofore paid at or  
2 before the time the license was issued the full annual  
3 license fee and the additional license tax for the year for  
4 which such license was granted may at any time during  
5 such year surrender such license to the clerk of the  
6 court of quarter sessions out of which the license issued  
7 and thereupon the county treasurer who collected such li-  
8 cense fee and additional license tax shall refund and  
9 pay to the licensee a proportionate amount of such li-  
10 cense fee and tax The amount of the license fee and  
11 additiional license tax to be refunded shall be based upon  
12 the unexpired portion of the year for which such license  
13 was granted

14 Section 2 Upon the return of any such license fee  
15 and additional license tax to the licensee as herein pro-  
16 vided the county treasurer shall notify the State Treasurer  
17 and the municipality to whom a part of such license fee  
18 has been paid that the licensee has surrendered his license  
19 and that the proper proportion of the annual license fee  
20 and additional license tax was refunded according to the  
21 provisions of this act and shall request the State Treas-  
22 urer and such municipality to return and pay into the  
23 county treasury their respective portion of such fee and  
24 tax so refunded to the licensee It shall be the duty of  
25 the State Treasurer and such municipality on receipt of  
26 such notice and request to return to the county treasurer  
27 such proportionate amount of the license fee and tax re-  
28 ceived by the State and municipality as may be necessary

1 to reimburse the county for any moneys refunded to the  
2 licensee

3 Section 3 The annual license fees, and additional li-  
4 cense taxes paid into the State Treasury before the pass-  
5 age of this act by the county treasurer of any county  
6 or such part thereof as may be necessary are hereby speci-  
7 fically appropriated for the purpose of reimbursing any  
8 county for any moneys paid out of its treasury under  
9 the provisions of this act
