AN ACT

To amend part of section one of an act approved the eleventh day of July one thousand nine hundred and one (Pamphlet Laws six hundred and sixty-three) entitled "An act to regulate and establish the fees to be charged by sheriffs in this Commonwealth and to provide for the taxation and collection of the same" as amended

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 so much of section one of an act approved the eleventh
5 day of July one thousand nine hundred and one (Pam-
6 phlet Laws six hundred and sixty-three) entitled "An act
7 to regulate and establish the fees to be charged by
8 sheriffs in this Commonwealth and to provide for the
9 taxation and collection of the same" as amended by an
10 act approved the first day of June one thousand nine

1 hundred and fifteen (Pamphlet Laws six hundred and
2 seventy-seven) entitled "An act to amend an act approved
3 the eleventh day of July one thousand nine hundred one
4 entitled 'An act to regulate and establish the fees to be
5 charged by sheriffs in this Commonwealth and to provide
6 for the taxation and collection of the same'" which reads
7 as follows

8 "For traveling expenses or mileage in serving or exe-
9 cuting any of the writs rules orders decrees processes or
10 performing any of the duties or services herein specified
11 and intended so to be or authorized by law the sheriff
12 shall be entitled to receive and have taxed as costs six
13 cents a mile for each mile actually traveled and neces-
14 sary the same to be allowed on each separate writ rule
15 order decree process or service performed He shall not
16 receive more than one mileage where the plaintiff and
17 defendant or plaintiffs and defendants in two or more
18 contemporaneous writs are the same nor shall he receive
19 more than one mileage when conducting two or more
20 prisoners at one time to or from a place of detention
21 or correction whether he is authorized by one or more
22 writs" is hereby amended to read as follows

23 For traveling expenses or mileage in serving or exe-
24 cuting any of the writs rules orders decrees processes or
25 performing any of the duties or services herein specified
26 and intended so to be or authorized by law the sheriff
27 shall be entitled to receive and have taxed as costs ten
28 cents a mile for each mile actually traveled and neces-
29 sary the same to be allowed on each separate writ rule
