AN ACT

Making an appropriation to the Eastern State Penitentiary
at Philadelphia Pennsylvania

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 *the sum of four hundred sixty-nine thousand seven hun-*
5 *dred fifteen dollars and thirty-seven cents (\$469,715.37) or*
6 *so much thereof as may be necessary is hereby spe-*
7 *cifically appropriated to the Eastern State Penitentiary at*
8 *Philadelphia Pennsylvania for the two fiscal years begin-*
9 *ning June first one thousand nine hundred and nineteen*
10 *for the following purposes*

11 For salaries of officers and parole work the sum of
12 three hundred sixty thousand dollars (\$360,000) or so
13 much thereof as may be necessary

14 For general repairs the sum of twenty-five thousand
15 dollars (\$25,000) or so much thereof as may be neces-
16 sary

1 For gratuities paid discharged convicts for each dis-
2 charged convict from the city of Philadelphia or whose
3 residence is within fifty miles thereof the sum of five
4 dollars and for each discharged convict whose residence is
5 more than fifty miles from the city of Philadelphia the
6 sum of ten dollars the sum of ten thousand dollars
7 (\$10,000) or so much thereof as may be necessary

8 For clothing furnished discharged convicts the sum of
9 eighteen thousand dollars (\$18,000) or so much thereof as
10 may be necessary

11 For library books and stationery the sum of five
12 hundred dollars (\$500) or so much thereof as may be
13 necessary

14 To reimburse funds of treasurer for amount expended
15 for salaries of officers and parole work in excess of ap-
16 propriation awarded under act of the eighteenth day of
17 June one thousand nine hundred fifteen and insufficient re-
18 imbursement under act of July twenty-five one thousand
19 nine hundred seventeen the sum of fifteen hundred forty-
20 five dollars and thirty-seven cents (\$1,545.37) or so much
21 thereof as may be necessary

22 To reimburse funds of treasurer for amount expended
23 for salaries of officers and parole work in excess of ap-
24 propriation awarded under act of July twenty-fifth one
25 thousand nine hundred seventeen the sum of six thousand
26 dollars (\$6,000) or so much thereof as may be necessary

27 To reimburse funds of treasurer for amount expended
28 for general repairs in excess of appropriations awarded
29 under act of July twenty-fifth one thousand nine hundred

1 seventeen the sum of ten thousand dollars (\$10,000) or
2 so much thereof as may be necessary

3 To reimburse funds of treasurer for amount expended
4 for clothing furnished discharged convicts in excess of ap-
5 propriation awarded under act of July twenty-fifth one
6 thousand nine hundred seventeen the sum of two thousand
7 dollars (\$2,000) or so much thereof as may be necessary

8 To reimburse funds of treasurer for amount expended
9 in purchase of an automobile truck the sum of one
10 thousand six hundred seventy dollars (\$1,670) or so much
11 thereof as may be necessary

12 To reimburse funds of treasurer for amount expended
13 in making changes and additions to heating system and
14 boiler plant the sum of thirty-five thousand dollars (\$35,-
15 000) or so much thereof as may be necessary
