INTRODUCED BY MR. RAMSEY, MARCH 17, 1919.

REFERRED TO COMMITTEE ON APPROPRIATIONS, MARCH 18, 1919.

AN ACT

Making an appropriation to the Retirement Board for the purposes of carrying out the provisions of the act approved the eighteenth day of July one thousand nine hundred and seventeen (Pamphlet Laws one thousand and forty-three) entitled "An act establishing a public school employes' retirement system and creating a retirement board for the administration thereof establishing certain funds from contributions by the Commonwealth and contributing employes defining the uses and purposes thereof and the manner of payments therefrom and providing for the guaranty by the Commonwealth of certain of said funds imposing powers and duties upon boards having the employment of public school employes exempting annuities allowances returns benefits and rights from taxation and judicial process and providing penalties"

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 *the sum of two million one hundred forty-seven thousand*
5 *two hundred six dollars and forty-four cents (\$2,147,206.44)*
6 *is hereby specifically appropriated to the Retirement Board*
7 *created by the act approved the eighteenth day of July*
8 *one thousand nine hundred and seventeen (Pamphlet Laws*
9 *one thousand and forty-three) entitled "An act establishing*
10 *a public school employes' retirement system and creating a*
11 *retirement board for the administration thereof establishing*
12 *certain funds from contributions by the Commonwealth and*
13 *contributing employes defining the uses and purposes thereof*
14 *and the manner of payments therefrom and providing for*
15 *the guaranty by the Commonwealth of certain of said*
16 *funds imposing powers and duties upon boards having the*
17 *employment of public school employes exempting annuities*
18 *allowances returns benefits and rights from taxation and*
19 *judicial process and providing penalties" for the following*
20 *purposes namely*

21 For the expense fund created by said act to be
22 used for the payment of the salaries of the secretary
23 actuary chief clerk assistant clerks and stenographers post-
24 age expressage traveling expenses contingent fund and other
25 incidental legal expenses the sum of seventy-four thousand
26 four hundred dollars (\$74,400.00) or so much thereof as
27 may be necessary for the two fiscal years beginning June
28 first one thousand nine hundred and nineteen

1 For payment into the contingent reserve fund as pro-
2 vided for by clause three of section eight of said act
3 the sum of ninety-two thousand eight hundred and eighty
4 dollars (\$92,880.00)

5 For payment into the annuity reserve fund number two
6 as provided for by clause five of section eight of said
7 act the sum of one million nine hundred seventy-nine
8 thousand nine hundred twenty-six dollars and forty-four
9 cents (\$1,979,926.44)
