To amend section one of an act approved the fourteenth day of April one thousand nine hundred and five (Pamphlet Laws one hundred sixty-nine) entitled "An act making it unlawful to trespass upon land posted as private property and providing the penalty therefor" permitting persons to lawfully hunt and fish on wild or unimproved lands other than game preserves lands used for resort purposes and lands lying along streams used for domestic purposes

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 section one of an act approved the fourteenth day of
5 April one thousand nine hundred and five (Pamphlet Laws
6 one hundred sixty-nine) entitled "An act making it unlaw-
7 ful to trespass upon land posted as private property and
8 providing the penalty therefor" which reads as follows

9 "Section 1 *Be is enacted by the Senate and House*

4 of this act it shall be unlawful for any person wilfully
5 to enter upon any land within the limits of this Com-
6 monwealth where the owner or owners of said land has
7 caused to be prominently posted upon said land printed
8 notices that the said land is private property and warn-
9 ing all persons from trespassing thereon under the penal-
10 ties provided in this act" be and the same is hereby
11 amended to read as follows

12 Section 1 Be it enacted by the Senate and House
13 of Representatives of the Commonwealth of Pennsylvania in
14 General Assembly met and it is hereby enacted by the
15 authority of the same That from and after the passage
16 of this act it shall be unlawful for any person willfully
17 to enter upon any land within the limits of this Com-
18 monwealth where the owner or owners of said land has
19 caused to be prominently posted upon said land printed
20 notices that the said land is private property and warn-
21 ing all persons from trespassing thereon under the penal-
22 ties provided in this act Provided however That the pro-
23 visions of this act shall not prohibit any person from
24 lawfully hunting or fishing on wild or unimproved lands
25 other than public State game preserves auxiliary State
26 game preserves properly licensed private preserves and
27 lands set apart to hospitals or sanatorium or park resort
28 uses nor to any lands within one-half mile of any open
29 stream the water from which is used for domestic pur-

1 poses by the public generally notwithstanding that such
2 wild or unimproved lands are posted as provided for in
3 this act
