AN ACT

To amend the act approved the thirtieth day of March one thousand nine hundred seventeen (Appropriation Acts sixteen) entitled "An act making an appropriation for the purpose of continuing and maintaining schools among the Cornplanter Indians of Warren County"

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 *section one of the act approved the thirtieth day of*
5 *March one thousand nine hundred seventeen (Appropriation*
6 *Acts sixteen) entitled "An act making an appropriation*
7 *for the purpose of continuing and maintaining schools*
8 *among the Cornplanter Indians of Warren County" which*
9 *reads as follows*

10 "Section 1 *Be it enacted by the Senate and House*
11 *of Representatives of the Commonwealth of Pennsylvania in*
12 *General Assembly met and it is hereby enacted by the*

1 authority of the same That the annual sum of six hun-
2 dred dollars (\$600) be and the same is hereby speci-
3 fically appropriated out of any money in the treasury not
4 otherwise appropriated to be paid to the county superin-
5 tendent of schools of Warren County on warrant drawn
6 on the State Treasurer by the State Superintendent of
7 Public Instruction which money shall be disbursed by the
8 said superintendent of Warren County in such manner as
9 shall best promote the cause of education among the
10 Cornplanter Indians Provided that the appropriation under
11 this act shall commence with the first Monday of June
12 one thousand nine hundred and fifteen at which time the
13 last preceding appropriation act for such purpose expired
14 and shall only continue in force for the period of ten
15 years from that day and shall terminate on the first
16 Monday of June one thousand nine hundred and twenty-
17 five" is hereby amended to read as follows

18 Section 1 Be it enacted by the Senate and House
19 of Representatives of the Commonwealth of Pennsylvania in
20 General Assembly met and it is hereby enacted by the
21 authority of the same That the annual sum of eight
22 hundred dollars (\$800) be and the same is hereby speci-
23 fically appropriated out of any money in the treasury
24 not otherwise appropriated to be paid to the county
25 superintendent of schools of Warren County on warrant
26 drawn on the State Treasurer by the State Superintendent
27 of Public Instruction which money shall be disbursed by
28 the said superintendent of Warren County in such manner
29 as shall best promote the cause of education among the

1 Cornplanter Indians Provided that the appropriation under
2 this act shall commence with the first Monday of June
3 one thousand nine hundred and nineteen and shall only
4 continue in force for the period from that day until
5 the first Monday of June one thousand nine hundred and
6 twenty-five
