AN ACT

To amend section one of an act approved the eighth day of June one thousand nine hundred and eleven (Pamphlet Laws seven hundred twelve) entitled "An act relating to milk providing for the protection of the public health and the prevention of fraud and deception by regulating the sale of milk skimmed milk and cream providing penalties for the violation thereof and providing for the enforcement thereof"

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 section one of an act approved the eighth day of June
5 one thousand nine hundred and eleven (Pamphlet Laws
6 seven hundred twelve) entitled "An act relating to milk
7 providing for the protection of the public health and the
8 prevention of fraud and deception by regulating the sale
9 of milk skimmed milk and cream providing penalties for

2 thereof" which reads as follows

3 "Section 1 Be it enacted by the Senate and House
4 of Representatives of the Commonwealth of Pennsylvania in
5 General Assembly met and it is hereby enacted by the
6 authority of the same That it shall be unlawful for any
7 person firm or corporate body by himself herself itself or
8 themselves or by his her its or their agents servants or
9 employes to sell offer for sale expose for sale or have
10 in possession with intent to sell milk which contains any
11 added water or milk which has had the butter-fat or
12 any portion thereof removed therefrom or milk to which
13 has been added any substance for the purpose of in-
14 creasing its consistency or thickness or milk which con-
15 tains less than three and one-quarter (3 $\frac{1}{4}$) per centum of
16 butter-fat and less than twelve (12) per centum of milk
17 solids Provided however That skimmed milk when clean
18 and wholesome may be sold if sold as skimmed milk"
19 is hereby amended to read as follows

20 Section 1 Be it enacted by the Senate and House
21 of Representatives of the Commonwealth of Pennsylvania in
22 General Assembly met and it is hereby enacted by the
23 authority of the same That it shall be unlawful for
24 any person firm or corporate body by himself herself it-
25 self or themselves or by his her its or their agents
26 servants or employes to sell offer for sale expose for
27 sale or have in possession with intent to sell milk
28 which contains any added water or milk which has had
29 the butter-fat or any portion thereof removed therefrom or

1 milk to which has been added any substance for the
2 purpose of increasing its consistency or thickness or milk
3 which contains less than three and one-half (3½) per
4 centum of butter-fat and less than twelve (12) per
5 centum of milk solids Provided however That skimmed
6 milk when clean and wholesome may be sold if sold as
7 skimmed milk
