**AN ACT**

Amending the act of March 10 1949 (P L 30) entitled "An act relating to the public school system including certain provisions applicable as well to private and parochial schools amending revising consolidating and changing the laws relating thereto" changing provisions relating to the approval of projects for reimbursement purposes

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

1 Section 1 Subsection (a) of section 2577 act of March 10 1949  
2 (P L 30) known as the "Public School Code of 1949" amended December  
3 22 1959 (P L 1074) is amended to read

4 Section 2577 Limitations on Approval of Projects for Reimburse-  
5 ment Purposes (a) The Superintendent of Public Instruction shall not  
6 give his approval for reimbursement purposes to any phase of any pro-  
7 ject to be undertaken by the State Public School Building Authority  
8 or by any municipality authority or nonprofit corporation under section  
9 758 of this act or any profit or nonprofit corporation partnership  
10 association or person under section 791 of this act or by any school  
11 district that would cause the approved reimbursable costs of projects  
12 to exceed [one billion one hundred fifty million dollars (\$1,150,000,000)  
13 during the school year 1959-1960 and one billion three hundred million  
14 dollars (\$1,300,000,000) during the school year 1960-1961] one billion  
15 six hundred million dollars (\$1,600,000,000) during the school year  
16 1961-1962 one billion nine hundred million dollars (\$1,900,000,000)  
17 during the school year 1962-1963 and two billion two hundred million  
18 dollars (\$2,200,000,000) during the school year 1963-1964 in the aggre-  
19 gate for all the authorities nonprofit corporations profit or nonprofit  
20 corporations partnerships associations or persons and school districts

1 combined for projects already undertaken and to be undertaken
