AN ACT

Amending the act of April 9 1929 (P L 177) entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments boards commissions and officers thereof including the boards of trustees of State Normal Schools or Teachers Colleges abolishing creating reorganizing or authorizing the reorganization of certain administrative departments boards and commissions defining the powers

and duties of the Governor and other executive and administrative officers and of the several administrative departments boards commissions and officers fixing salaries of the Governor Lieutenant Governor and certain other executive and administrative officers providing for the appointment of certain administrative officers and of all deputies and other assistants and employes in certain departments boards and commissions and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments boards and commissions shall be determined" providing for a board of trustees for the West Philadelphia State College

The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows

13 Section 401 Boards of Trustees of State Institutions The boards
14 of trustees of each of the State institutions hereinafter mentioned shall
15 consist of nine members and the head of the department having super-
16 vision over the institution ex officio

17 The terms of each member of each such board shall be six years
18 and until his successor is appointed and qualified

19 The terms of the first three members of all boards the members
20 of which now serve for terms of four years appointed by the Governor

1 on or after the third Tuesday of January 1959 shall expire
2 on the third Tuesday of January 1961 The terms of the next
3 three members appointed shall expire on the third Tuesday of January
4 1963 The terms of the next three members appointed shall expire on
5 the third Tuesday of January 1965 The terms of the members of each
6 board hereafter created shall be so staggered so that the terms of three
7 members of the board shall expire every two years Their successors
8 and all members of all boards appointed to succeed members who have
9 served six year terms shall be appointed for terms of six years from
10 the date of the expiration of the preceding term Vacancies happening
11 before the expiration of a term shall be filled for the unexpired term

12 Five members of any such board shall constitute a quorum

13 Each such board shall annually elect a president and vice-president
14 from among its members and a secretary and treasurer who need not
15 be members of the board The secretary and treasurer may be the same
16 person
