AN ACT

Amending the act of May 3 1923 (P L 134) entitled "An act making the proceedings of the conventions of the Departments of Pennsylvania of the Grand Army of the Republic and the United Spanish War Veterans a part of the public records of the State and providing for their publication and distribution" correcting the name of the Italian American World War Veterans of the United States Incorporated to conform with its charter

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

15 Incorporated shall report to the Department of Property and Supplies
16 the proceedings of the annual encampment or conventions of their
17 respective departments with such general and special orders and circulars
18 and other data which may form a part of said proceedings then the said
19 proceedings so reported shall be considered State records and under the
20 direction of the Department of Property and Supplies shall be printed

1 and bound and a printed and bound copy thereof shall be sent to each
 2 post or detachment in the Commonwealth of Pennsylvania of the organ-
 3 ization of whose proceedings the same is a report
