AN ACT

Amending the act of March 10 1949 (P L 30) entitled "An act relating to the public school system including certain provisions applicable as well to private and parochial schools amending revising consolidating and changing the laws relating thereto" providing for additional payments to certain school districts

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

17 school district suffers a loss in total State subsidies under the afore-
18 mentioned sections by virtue of increased market valuations as certified
19 to the Superintendent of Public Instruction by the State Tax Equaliza-

1 tion Board the Commonwealth shall pay during the school [year] years
 2 1960-1961 and 1961-1962 one hundred per centum (100%) of such loss
 3 computed by subtracting the amount to which the school district is
 4 entitled under the aforementioned sections from the amount to which
 5 the school district would be entitled on the basis of the market valua-
 6 tions certified to the Superintendent of Public Instruction by the State
 7 Tax Equalization Board in the year 1958
