The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

1 Section 1 Sections 4 5 7 8 and 9 act of June 1 1956 (P L 1959)

10 Section 4 The annual salary of each of the judges of the courts of
11 common pleas of the first and fifth judicial districts shall be [twenty-
12 two thousand five hundred dollars (\$22,500)] twenty-five thousand dol-
13 lars (\$25,000)

14 With the exception of the judges of the courts of common pleas of

1 Dauphin County the annual salary of each of the judges of the courts
2 of common pleas learned in the law in judicial districts having a popula-
3 tion of more than two hundred and fifty thousand and less than one
4 million inhabitants shall be [twenty thousand dollars (\$20,000)] twenty-
5 two thousand five hundred dollars (\$22,500) in judicial districts having
6 a population of one hundred thousand and more but less than two hun-
7 dred fifty thousand inhabitants shall be [twenty thousand dollars \$20,-
8 000)] twenty-two thousand five hundred dollars (\$22,500) in judicial
9 districts having a population of sixty-five thousand or more and less
10 than one hundred thousand inhabitants shall be [nineteen thousand
11 dollars (\$19,000)] twenty-one thousand five hundred dollars (\$21,500)
12 in judicial districts having a population of less than sixty-five thousand
13 inhabitants [eighteen thousand dollars (\$18,000)] twenty thousand five
14 hundred dollars (\$20,500) The amount of the salaries to be paid under
15 this paragraph in the several judicial districts shall be determined and
16 fixed according to the population of such districts as ascertained by
17 reference from time to time to the last preceding decennial United
18 States Census

19 Section 5 The judges of the courts of common pleas of Dauphin
20 County and the judges of the orphans' court of Dauphin County shall

1 each receive [twenty-five thousand dollars (\$25,000)] twenty-seven
2 thousand five hundred dollars (\$27,500) annually

3 Section 7 The annual salary of the President Judge of the Munic-
4 ipal Court of Philadelphia shall be [eighteen thousand five hundred
5 dollars (\$18,500)] twenty-three thousand dollars (\$23,000) and the
6 annual salary of each of the other judges of the Municipal Court of
7 Philadelphia shall be [eighteen thousand dollars (\$18,000)] twenty-two
8 thousand five hundred dollars (\$22,500)

9 Section 8 The annual salary of the President Judge of the County
10 Court of Allegheny County shall be [eighteen thousand five hundred
11 dollars (\$18,500)] twenty-one thousand dollars (\$21,000) and the annual
12 salary of each of the other judges of the County Court of Allegheny
13 County shall be [eighteen thousand dollars (\$18,000)] twenty thousand
14 five hundred dollars (\$20,500)

15 Section 9 The annual salary of the judge of the Juvenile Court of
16 Allegheny County shall be [eighteen thousand dollars (\$18,000)]
17 twenty thousand five hundred dollars (\$20,500)

18 Section 2 This act shall take effect immediately
