AN ACT

Amending the act of May 1 1933 (P L 103) entitled "An act concerning townships of the second class and amending revising consolidating and changing the law relating thereto" authorizing the condemnation of land for ~~garbage disposal and land fill operations~~ **PURPOSES.**

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

1 Section 1 Clause VIII of section 702 act of May 1 1933 (P L 103)
2 known as "The Second Class Township Code" reenacted and amended

5 Section 702 Supervisors to Exercise Powers The corporate powers
6 of townships of the second class shall be exercised by the township
7 supervisors Where no specific authority is given for the expenditures
8 incident to the exercise of any power hereinafter conferred or where
9 no specific fund is designated from which such expenditures shall be
10 made appropriations for such expenditures shall be made only from
11 the general township fund In addition to the duties imposed upon
12 them by section five hundred sixteen hereof they shall have power

14 VIII Ashes Garbage Rubbish and Other Refuse Materials To
15 regulate or prohibit the dumping or otherwise depositing of ashes
16 garbage rubbish and other refuse materials within the township To
17 prohibit accumulations of ashes garbage rubbish and other refuse ma-
18 terials upon private property including the imposition and collection of
19 reasonable fees and charges for the collection removal and disposal
20 thereof They shall also have power to

1 (1) Collect remove and dispose of or to provide by contract or
2 otherwise for the collection removal and disposal by incineration land
3 fill or other methods of ashes garbage rubbish and other refuse materials
4 and to prescribe penalties for the enforcement thereof Any such
5 contract may be made for a period not exceeding three years This
6 limitation shall not apply to contracts entered into with any other
7 political subdivision or with any municipality authority To acquire
8 either amicably or by exercising the power of eminent domain in the
9 manner provided in article ten of this act any real property and to
10 erect maintain improve operate and lease either as lessor or lessee fa-
11 cilities for incineration land fill or other methods of disposal either
12 within or without the limits of the township including equipment either
13 separately or jointly with any other political subdivision or with any
14 municipality authority in order to provide for the destruction collection
15 removal and disposal of ashes garbage rubbish and other refuse materials
16 and to provide for the payment of the cost and expense thereof either
17 in whole or part out of the funds of the township and to acquire LAND
18 FOR LAND FILL PURPOSES either amicably or by exercising the
19 power of eminent domain and to maintain SUCH lands and places for
20 the dumping of ashes garbage rubbish and other refuse material to

1 fix alter charge and collect rates and other charges for the col-
2 lection removal and disposal of ashes garbage rubbish and other
3 refuse materials and the cost of including the payment of any in-
4 debtedness incurred for the construction purchase improvement re-
5 pair maintenance and operation of any facilities therefor and the amount
6 due under any contract with any other political subdivision or with any
7 municipality authority furnishing any of such services or facilities To
8 incur indebtedness and issue bonds for the costs of the construction pur-
9 chase improvement and repair of any facilities for the collection removal
10 and disposal of ashes garbage rubbish and other refuse materials in-
11 cluding equipment to be used in connection therewith To make ap-
12 propriations to any other political subdivision or any municipality au-
13 thority out of its general funds or out of any other available funds in-
14 cluding the proceeds of bonds of the township for the construction
15 purchase improvement repair maintenance and operation of any facili-
16 ties for the collection removal and disposal of ashes garbage rubbish
17 and other refuse materials In the event that any such bonds were issued
18 for such purposes pursuant to a vote of the electors any appropriation
19 of such proceeds as above set forth shall not be deemed such a change
20 of purpose from that for which such bonds were issued as shall require

1 the question to be again submitted to a vote of the electors under any
2 existing law Any such funds appropriated as herein authorized which
3 represent the proceeds of any bonds heretofore or hereafter issued by
4 the township for the above purposes shall be used by such other political
5 subdivision or municipality authority for or toward the purpose or
6 purposes for which such bonds were issued In the absence of such
7 collection removal and disposal plan for the entire township the super-
8 visors shall

9 (2) on petition of a majority of the adult taxable residents of any
10 territory within the township which has been definitely defined set apart
11 and limited by the township supervisors with the approval of the town-
12 ship auditors as a village prior to the filing of any such petition either
13 with township employes and facilities or with independent contractors
14 provide for the removal from the village of ashes or garbage or other
15 refuse material as the case may be and for the disposal thereof The
16 Supervisors shall levy a per capita assessment upon all adult residents
17 of any such village sufficient to defray the cost of such removal and
18 disposal Such assessment shall be collected in the same manner as per

1 capita taxes and the collector shall receive the same commission thereon
 2 The treasurer of the board of supervisors shall receive all such assess-
 3 ments collected and keep the same in a separate account and pay the
 4 same out only upon orders signed by the chairman and attested by the
 5 secretary of the board of supervisors The treasurer shall make an
 6 annual report of the account to the auditors of the township
