AN ACT

To provide for an additional law judge of the court of common pleas

in the thirty-sixth judicial district and making an appropriation

The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows

- 1 Section 1 In addition to the judges provided for in the act of Jan-
- 2 uary 8 1952 (P L 1844) entitled "An act to designate the several
- 3 judicial districts of the Commonwealth as required by the Constitution.

2 ized and provided for the court of common pleas of the thirty-sixth
3 judicial district who shall possess the same qualifications which are re-
4 quired by the Constitution and laws for the president judge of the
5 court of common pleas of the district and who shall hold his office for a
6 like term and by the same tenure and shall have the same power au-
7 thority and jurisdiction and shall be subject to the same duties restric-
8 tions and penalties and shall receive the same compensation provided for
9 by law for judges learned in the law as if the same office had been es-
10 tablished in the time of and subject to the provisions of the act of
11 June 1 1956 (P L 1959) entitled "An act fixing the salaries and compen-
12 sation of the Chief Justice and judges of the Supreme Court the Presi-
13 dent Judge and judges of the Superior Court the judges of the courts
14 of common pleas the judges of the orphans' courts the judges of the
15 Municipal Court of Philadelphia and the judges of the County Court
16 and Juvenile Court of Allegheny County certain associate judges not
17 learned in the law certain State officers and the salary and expenses of

20 Section 2 At the municipal election in November ~~1961~~ 1963 the

1 qualified electors of the thirty-sixth judicial district shall elect in the same
2 manner prescribed by law for the election of the president judge of the
3 court of common pleas of the district one competent person learned
4 in the law to serve as an additional law judge of the court of common
5 pleas of the thirty-sixth judicial district from the first Monday in Jan-
6 uary ~~1962~~ 1964 for a term of ten years Vacancies in the office hereby
7 created whether caused by death resignation expiration of term or other-
8 wise shall be filled in the same manner as is required by law in case of a
9 similar vacancy in the office of president judge of the court

10 Section 3 The Governor is hereby authorized to appoint a compe-
11 tent person learned in the law as such additional law judge of the court
12 of common pleas of the said thirty-sixth judicial district to serve until
13 the first Monday of January ~~1962~~ 1964

14 Section 4 The sum of ~~ten thousand dollars (\$10,000)~~ SEVENTEEN
15 THOUSAND DOLLARS (\$17,000) or so much thereof as may be neces-
16 sary is hereby appropriated for the purpose of paying the salary of the
17 additional law judge provided by this act during the fiscal period ending
18 June 30 ~~1961~~ 1962

19 Section 5 This act shall take effect immediately
