## AN ACT

Amending the act of June 24 1939 (P L 872) entitled "An act to consolidate amend and revise the penal laws of the Commonwealth" requiring a copy of the application to be sent to the police or the sheriff where **THE SELLER'S PLACE OF BUSINESS IS LOCATED AND WHERE** the buyer resides

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

6 (h) Time and Manner of Delivery Statement To Be Signed by  
7 Purchaser Sales at Wholesale No seller shall deliver a firearm to the  
8 purchaser thereof until forty-eight (48) hours shall have elapsed from  
9 the time of the application for the purchase thereof and when de-  
10 livered said firearm shall be securely wrapped and shall be unloaded  
11 At the time of applying for the purchase of a firearm the purchaser  
12 shall sign in [triplicate] quadruplicate and deliver to the seller a state-  
13 ment containing his full name address occupation color place of birth the  
14 date and hour of application the caliber length of barrel make model and  
15 manufacturer's number of the firearm to be purchased and a statement  
16 that he has never been convicted in this Commonwealth or elsewhere  
17 of a crime of violence The seller shall within six hours after such applica-  
18 tion sign and attach his address and forward by registered mail one copy  
19 of such statement to the chief or head of the police force or police de-  
20 partment of the city or the sheriff of the county of [which the seller is]

1 **[a resident]** THE SELLER'S PLACE OF BUSINESS the duplicate  
 2 duly signed by the seller shall within seven days be sent by him with  
 3 his address to the Commissioner of the Pennsylvania State Police the  
 4 triplicate he shall retain for six (6) years and the quadruplicate with  
 5 the proper signature and address of the seller shall within six (6) hours  
 6 after such application be forwarded by registered mail to the chief or  
 7 head of the police force or police department of the city or to the  
 8 sheriff of the county of which the buyer is a resident This clause shall  
 9 not apply to sales at wholesale
