AN ACT

Amending the act of June 1 1931 (P L 299) entitled "An act requiring retail dealers in liquid fuels to state the rate of the liquid fuels tax separately from the price of such liquid fuels on liquid fuel price display signs and imposing a penalty" changing provisions relating to posting of signs

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

4 Section 1 Be it enacted &c That every person copartnership asso-
5 ciation or corporation engaged in the retail sale of liquid fuels as de-
6 fined by law for purposes of taxation shall state and post on each pump
7 or other dispensing unit from which liquid fuels are sold to the public
8 by means of a sign [or] placard [not less than ten inches in height and
9 twelve inches in width nor larger than twelve inches in height and
10 twelve inches in width] quantity computing device or combination of
11 both stating clearly and legibly [in letters and numbers of uniform
12 size and coloring] the selling price per gallon of liquid fuels so sold
13 or offered for sale from such pump or other dispensing unit together
14 with the name symbol trade name brand or mark of such liquid fuel
15 and if the seller uses a grade or quality classification in marketing liquid
16 fuel such grade or quality classification shall be also stated thereon
17 In stating the price at which the liquid fuels are sold or offered for
18 sale per gallon there shall be stated separately on such sign or placard
19 the amount of State tax per gallon the amount of federal tax per gal-
20 lon and the amount other than taxes charged for liquid fuels per gal-

1 lon and the total of these amounts No sign or placard showing the
2 price or prices of liquid fuels sold or offered for sale or relating to
3 price or prices other than the signs or placards hereinbefore provided
4 for shall be posted or displayed on the premises on which liquid fuels
5 are sold or offered for sale or any other place or places adjacent there-
6 to unless the signs or placards shall be [similar as to size uniformity
7 and coloring of figures and lettering to the sign signs or placard posted
8 on the pump or pumps or other dispensing devices and which shall be
9 visible to the public Provided however That when the total selling
10 price to be paid is clearly shown and displayed on a quantity computing
11 device or calculator attached to the pump from which such gasoline
12 is sold or offered for sale such posting of price thereon shall be con-
13 sidered sufficient compliance with this section] at least a minimum of
14 ten feet from the ~~right of way~~ CURB EDGE OF THE PAVED HIGH-
15 WAY OR BERM The Department of Revenue is hereby authorized to
16 make regulations for the enforcement of this act
