AN ACT

Amending the act of March 10 1949 (P L 30) entitled "An act relating to the public school system including certain provisions applicable as well to private and parochial schools amending revising consolidating and changing the laws relating thereto" providing for the use of moneys in the State School Fund of Pennsylvania for making grants to certain school districts

The General Assembly of the Commonwealth of Pennsylvania

hereby enacts as follows

1 Section 1 Section 2604 act of March 10 1949 (P L 30) known as  
2 the "Public School Code of 1949" amended January 7 1960 (P L 2101)  
3 is amended to read

4 Section 2604 Use of Fund Appropriation In addition to equalizing  
5 educational opportunities throughout the Commonwealth and making  
6 grants to school districts which received grants out of the moneys of  
7 the State School Fund of Pennsylvania for two or more consecutive  
8 years prior to July 15 1959 the State Council of Education may expend  
9 moneys from the State School Fund of Pennsylvania for the purpose of  
10 paying a part of the costs of repairs and/or alterations to local public  
11 school buildings or buildings used by State [teacher's] colleges which  
12 repairs and/or alterations are necessary to satisfy fire and safety stand-  
13 ards or requirements and which are required by order of the Depart-  
14 ment of Labor and Industry or in those cases in which the Department  
15 of Labor and Industry does not have jurisdiction then by order of an-  
16 other governmental body of competent jurisdiction empowered by law  
17 to enforce such orders including cities of the first class cities of the  
18 second class and cities of the second class A

19 As much of the moneys in the State School Fund of Pennsylvania  
20 including principal and income as may be necessary is specifically ap-

1 appropriated to the State Council of Education to be used for the pur-

2 poses and in the manner prescribed in this act

3 Section 2 This act shall take effect immediately
