AN ACT

Amending the act of June 1 1956 (P L 1959) entitled "An act fixing the salaries and compensation of the Chief Justice and judges of the Supreme Court the President Judge and judges of the Superior Court the judges of the courts of common pleas the judges of the orphans' courts the judges of the Municipal Court of Philadelphia and the judges of the County Court and Juvenile Court of Allegheny County certain associate judges not learned in the law certain state officers and the salary and expenses of

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

1 Section 1 Sections 4 5 6 7 8 and 9 act of June 1 1956 (P L 1959)
2 entitled "An act fixing the salaries and compensation of the Chief Justice
3 and judges of the Supreme Court the President Judge and judges of
4 the Superior Court the judges of the courts of common pleas the judges
5 of the orphans' courts the judges of the Municipal Court of Philadelphia
6 and the judges of the County Court and Juvenile Court of Allegheny
7 County certain associate judges not learned in the law certain state
8 officers and the salary and expenses of the members of the General
9 Assembly and repealing certain inconsistent acts" are amended to read

10 Section 4 [The annual salary of each of the judges of the courts of
11 common pleas of the first and fifth judicial districts shall be {twenty-
12 two thousand five hundred dollars (\$22,500)] twenty five thousand dol-
13 lars (\$25,000)

14 With the exception of the judges of the courts of common pleas of

1 Dauphin County the annual salary of each of the judges of the courts
2 of common pleas learned in the law in judicial districts having a popula-
3 tion of more than [two] ONE hundred and fifty thousand [and less
4 than one million] inhabitants shall be [twenty thousand dollars (\$20,
5 000)] twenty-two thousand five hundred dollars (\$22,500) TWENTY-
6 FIVE THOUSAND DOLLARS (\$25,000) in judicial districts having
7 a population of one hundred thousand and more but less than [two]
8 ONE hundred fifty thousand inhabitants shall be [twenty thousand dol-
9 lars (\$20,000)] twenty-two thousand five hundred dollars (\$22,500) in
10 judicial districts having a population of sixty-five thousand or more and
11 less than one hundred thousand inhabitants shall be [nineteen thousand
12 dollars (\$19,000)] twenty-one thousand five hundred dollars (\$21,500)
13 in judicial districts having a population of less than sixty-five thousand
14 inhabitants [eighteen thousand dollars (\$18,000)] twenty thousand five
15 hundred dollars (\$20,500) The amount of the salaries to be paid under
16 this paragraph in the several judicial districts shall be determined and
17 fixed according to the population of such districts as ascertained by
18 reference from time to time to the last preceding decennial United
19 States census

1 Section 5 The judges of the courts of common pleas of Dauphin
2 County and the judges of the orphans' court of Dauphin County shall
3 each receive [twenty-five thousand dollars (\$25,000)] twenty-seven
4 thousand five hundred dollars (\$27,500) annually

5 SECTION 6 IN ANY COUNTY WHERE A SEPARATE
6 ORPHANS' COURT IS ESTABLISHED THE ANNUAL SALARY
7 OF EACH JUDGE OF THE ORPHANS' COURT SHALL BE THE
8 SAME AS IS PAID TO THE JUDGE OR JUDGES OF THE COURT
9 OR COURTS OF COMMON PLEAS IN SUCH COUNTY

10 Section 7 The annual salary of the President Judge of the Munic-
11 ipal Court of Philadelphia shall be [eighteen thousand five hundred
12 dollars (\$18,500)] twenty-three thousand dollars (\$23,000) and the
13 annual salary of each of the other judges of the Municipal Court of
14 Philadelphia shall be [eighteen thousand dollars (\$18,000)] twenty-two
15 thousand five hundred dollars (\$22,500)

16 Section 8 The annual salary of the President Judge of the County
17 Court of Allegheny County shall be [eighteen thousand five hundred
18 dollars (\$18,500)] twenty-one thousand dollars (\$21,000) and the annual
19 salary of each of the other judges of the County Court of Allegheny

1 County shall be [eighteen thousand dollars (\$18,000)] twenty thousand
2 five hundred dollars (\$20,500)

3 Section 9 The annual salary of the judge of the Juvenile Court of
4 Allegheny County shall be [eighteen thousand dollars (\$18,000)]
5 twenty thousand five hundred dollars (\$20,500).

6 Section 2 This act shall take effect immediately
