

of the act to which this is a supplement and hereinafter referred to as the commissioners, are hereby authorized and directed to provide and maintain a nautical school for the education and training of pupils in the science and practice of navigation, *seamanship, steam and electrical engineering*; to furnish accommodations on board a proper vessel for said school, and make all needful rules and regulations therefor, and for the number and compensation of instructors and others employed therein; to prescribe the government and discipline thereof, and the terms and conditions upon which pupils shall be received and instructed therein and discharged therefrom, and provide in all things for the good management of said nautical school. And the said commissioners shall have power to purchase the books, apparatus, stationery, and other things necessary or expedient to enable said school to be properly and successfully conducted, and may cause the said school or the pupils or part of the pupils thereof to go on board a vessel or vessels in the harbor of Philadelphia and take cruises in or from said harbor for the purpose of obtaining a practical knowledge in navigation and the duties of [marines] *mariners and engineers*. *If not residents of the Commonwealth of Pennsylvania, pupils may be admitted only upon the payment of such fees as shall be prescribed by the commissioners, based on the full annual per capita cost of educating such pupils. The moneys received from such fees shall be credited to the biennial appropriation to the board for the maintenance of a nautical school located at the port of Philadelphia, and the moneys so credited are hereby appropriated for the use of said board.* And the said commissioners are hereby authorized to receive from the United States Government such vessel or vessels as the Secretary of the Navy may detail for the use of said school.

AN ACT

To amend section one of an act, approved the twenty-sixth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws, seven hundred eighty-one), entitled "An act authorizing the Pennsylvania Historical Commission on behalf of the Commonwealth of Pennsylvania to acquire land in Falls Township, Bucks County, known as 'Pennsbury,' to be known thereafter as 'Pennsbury Memorial;' providing for the control, management, supervision, restoration, improvement, and maintenance thereof; authorizing the commission to make and enforce rules and regulations for the preservation and visitation thereof," by providing that in certain contingencies the land so acquired may revert to the donor.

Section 1. Be it enacted, &c., That section one of the act, approved the twenty-sixth day of April, one thousand nine hundred and twenty-nine (Pamphlet Laws, seven hundred eighty-one), entitled "An act authorizing the Pennsylvania Historical Commission on behalf of the Commonwealth of Pennsylvania to acquire land in Falls Township, Bucks County, known as 'Pennsbury,' to be known thereafter as 'Pennsbury Memorial;' providing for the control, management, supervision, restoration, improvement, and maintenance thereof; authorizing the commission to make and enforce rules and regulations for the preservation and visitation thereof," is hereby amended to read as follows:

Section 1. That the Pennsylvania Historical Commission be and it hereby is authorized to acquire, by gift, in the name of the Commonwealth of Pennsylvania, from the owners thereof, "Pennsbury," in Falls Township, Bucks County, where William Penn, proprietary of the Province of Pennsylvania, had his home: *Provided, That if at any time in the future the Commonwealth of Pennsylvania shall cease to designate and maintain said "Pennsbury" as an historical site, the land so acquired shall revert to the owners thereof, its successors or assigns; and, upon its acquisition, to preserve and maintain the same as an historical place, to be known as the "Pennsbury Memorial."*
