AN ACT

HB 12

Making a deficiency appropriation to the Legislative Reference Bureau for salaries, wages and necessary expenses.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of eleven thousand two hundred fifty dollars (\$11,250), or as much thereof as may be necessary, is hereby specifically appropriated to the Legislative Reference Bureau for payment of the deficiency in the appropriation to the Legislative Reference Bureau for the fiscal year July 1, 1964, to June 30, 1965, for the salaries, wages and all necessary expenses for the work of the Legislative Reference Bureau as provided in the act of May 7, 1923 (P. L. 158), as amended.

Section 2. This act shall take effect immediately.

HB 85

Amending the act of July 25, 1963 (Appropriation Act 21-A), entitled "An act making an appropriation to the Department of Property and Supplies for the payment of a grant to the Borough of Millersville for the Commonwealth's share of expenses and charges in connection with utilities expansions," including the reconstruction of East Frederick Street and Creek Drive, engineering fees and costs, land acquisition, legal fees and contingencies.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1, act of July 25, 1963 (Appropriation Act 21-A), entitled "An act making an appropriation to the Department of Property and Supplies for the payment of a grant to the Borough of Millersville for the Commonwealth's share of expenses and charges in connection with utilities expansions," is amended to read:

Section 1. The sum of three hundred fifty-two thousand five hundred dollars (\$352,500), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for payment to the Borough of Millersville to cover the Commonwealth's share of projects extending municipal utilities to the Millersville State College, including the reconstruction of East Frederick Street and Creek Drive, engineering fees and costs, land acquisition, legal fees and contingencies.

Section 2. This act shall take effect immediately.

HB 391

Making a supplemental appropriation to the Department of Commerce for the Pennsylvania Industrial Development Authority.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one million dollars (\$1,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce as a supplemental appropriation for the Pennsylvania Industrial Development Authority for the purposes set forth in the act of May 17, 1956 (P. L. 1609), known as the "Pennsylvania Industrial Development Authority Act."

Section 2. This act shall take effect immediately.

AN ACT

SB 410

Making an appropriation to the committee appointed by the General Assembly to investigate practices of the milk industry.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of fifty thousand dollars (\$50,000), or as much thereof as may be necessary, is hereby appropriated to the committee appointed by the General Assembly pursuant to 1965 Senate Concurrent Resolution, Serial No. 21, adopted by the Senate on February 9, 1965, and concurred in by the House on March 1, 1965, to conduct a complete investigation of allegations of wide-spread rebate in the milk industry, and determine whether or not the practices and systems prevailing for the payment of milk by processors to farmers and likewise the systems or practices for pricing and payment by consumers to processors and dealers and other alleged acts which constitute a violation of the Milk Control Law and all matters related thereto, including, but not confined to the amount of corporate taxes or other taxes paid or due to the Commonwealth by processors. The money shall be used for the payment of expenses of the committee and the members thereof in performance of its functions and duties.

Section 2. The sum appropriated shall be paid on warrant of the Auditor General in favor of either of the co-chairmen of the joint committee on the presentation of his requisition for the same. The co-chairmen of the joint committee shall, not later than thirty days after the termination of their term of office or until their successors are elected and also within thirty days after the adjournment sine die of this General Assembly, file an account with the Auditor General of the committee's expenses since the filing of any prior account.

Section 3. This act shall take effect immediately.

Lapsing the unexpended and unencumbered balance of an appropriation from the General Fund made to the Department of Property and Supplies by the act of July 3, 1947 (Appropriation Acts, ¹ page 48), and providing that such funds shall revert to the General Fund.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The unexpended and unencumbered balance of the appro-

priation of sixteen million dollars (\$16,000,000) to the Department of Property and Supplies from the General Fund by the act of July 3, 1947 (Appropriation Acts ¹ page 48), for the use at any existing or new State-owned institutions within the then Department of Welfare for land, construction, repairs and other projects is hereby lapsed and such funds shall revert to the General Fund in the State Treasury.

Section 2. This act shall take effect immediately.

SB 442

Lapsing the unexpended and unencumbered balance of an appropriation from the General Fund made to the Department of Health by the act of June 4, 1945 (Appropriation Acts, ¹ page 58), and providing that such funds shall revert to the General Fund.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The unexpended and unencumbered balance of the appropriation as approved by the Governor of ten million three hundred twenty-five thousand dollars (\$10,325,000) to the Department of Health from the General Fund by the act of June 4, 1945 (Appropriation Acts, ¹ page 58), for the purpose of acquiring land, construction and equipping of a State Health Laboratory, construction of buildings and other projects under certain Commonwealth health and safety programs, is hereby lapsed and such funds shall revert to the General Fund in the State Treasury.

Section 2. This act shall take effect immediately.

The act of July 29, 1953 (Appropriation Acts, ¹ page 18), entitled "An act making an appropriation from the Motor License Fund to the Department of Property and Supplies for the acquisition of land (with or without buildings thereon) and for the erection, construction or reconstruction and equipment of an office building thereon for the use of the Bureaus of Motor Vehicles and Highway Safety," is repealed and the appropriation of three million dollars (\$3,000,000) thereof shall revert to the Motor License Fund in the State Treasury.

Section 2. This act shall take effect immediately.

SB 568

Amending the act of March 23, 1964 (Appropriation Act 18-A), entitled "An act making appropriations to the Department of Public Welfare for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources," by crediting certain Motor License Fund damage payments to this appropriation.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 2, act of March 23, 1964 (Appropriation Act 18-A), entitled "An act making appropriations to the Department of Public Welfare for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources," is amended to read:

Section 2. The sum of one million two hundred seven thousand two hundred sixty-nine dollars (\$1,207,269), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for capital improvement projects for the Mental Health Services program, including movable equipment for new projects and various types of general improvements and alterations and construction at the State mental institutions. In addition to this amount, all moneys received from the Motor License Fund in payment for damages caused to the sewage disposal plant and system at White Haven State School and Hospital shall be credited to this appropriation as reimbursement for funds expended for replacement or construction of facilities necessitated by highway construction through the grounds of the institution.

Section 2. This act shall take effect immediately.

HB 934

Making an appropriation for the maintenance, repair and improvement of the Port of Philadelphia.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of six hundred thousand dollars (\$600,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce, Bureau of Port Operations of the City of Philadelphia, for the maintenance, repair and improvement of the Port of Philadelphia for the fiscal year July 1, 1965, to June 30, 1966.

The moneys so appropriated shall only be expended as authorized and directed by the Council of the City of Philadelphia, and shall be drawn from the State Treasury upon warrants drawn by the Auditor General upon requisition by the Chief of the Bureau of Port Operations of said city.

Making an appropriation to the Department of Labor and Industry to reimburse the State Workmen's Insurance Fund for the retrospective premium adjustment applicable to the policy year July 1, 1962, to June 30, 1963.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred eighty-five thousand nine hundred fifteen dollars (\$185,915), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Labor and Industry to reimburse the State Workmen's Insurance Fund for the General Fund's share of the retrospective premium adjustment applicable to the policy year July 1, 1962, to June 30, 1963.

Section 2. This act shall take effect immediately.

AN ACT

HB 980

Making an appropriation to the Department of Mines and Mineral Industries for the Appalachia and Abandoned Coal Mine Services Programs and other similar specified purposes; directing the Secretary of Mines and Mineral Industries to give priority to certain specified projects and to expend specified amounts thereon wherever possible; and crediting Federal funds which may be received for the same purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of five million five hundred thousand dollars (\$5,500,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Mines and Mineral Industries for the Appalachia and Abandoned Coal Mine Services Programs and for the purposes provided in clause (e) of section 1902 of the act known as "The Administrative Code of 1929," added by act of November 12, 1959 (P. L. 1502).

Section 2. The Secretary of Mines and Mineral Industries, in the use of this appropriation and all moneys received from the Federal Government as contributions for such programs, shall give priority to the following specified projects and expend the specified amounts thereon wherever possible:

(1) Backfilling (Flushing) Projects, nine million two hundred fifty thousand dollars (\$9,250,000).

(i) Scranton, Central City, one million two hundred thousand dollars (\$1,200,000).

(ii) Wilkes Barre, Spring Street, two hundred thousand dollars (\$200,000).

(iii) Wilkes Barre Heights, West, one million two hundred thousand dollars (\$1,200,000).

(iv) Coaldale, two hundred thousand dollars (\$200,000).

(v) Scranton, Central City East, one million one hundred thousand dollars (\$1,100,000).

(vi) Scranton, Central City West, one million one hundred thousand dollars (\$1,100,000).

(vii) Scranton, West Side, S. Morse School, one million dollars (\$1,000,000).

(viii) Plymouth, Main Street Area, five hundred thousand dollars (\$500,000).

(ix) Plymouth, Oak Street, seven hundred fifty thousand dollars (\$750,000).

(x) Ashley, Cook, Fall Street, two million dollars (\$2,000,000).

(2) Mine Fire Control Projects, eleven million one hundred fifty thousand dollars (\$11,150,000).

(i) Laurel Run, Luzerne County, four million dollars (\$4,000,000).

(ii) Kehley Run, Schuylkill County, four million five hundred thousand dollars (\$4,500,000).

(iii) Centralia, Columbia County, two million five hundred thousand dollars (\$2,500,000).

(iv) Collier Township, Allegheny County, forty thousand dollars (\$40,000).

(v) Kennedy Township, Allegheny County, forty thousand dollars (\$40,000).

(vi) Buena Vista, Allegheny County, forty thousand dollars (\$40,000).

(vii) Rostraver, Westmoreland County, thirty thousand dollars (\$30,000).

(3) Restoration of Abandoned Strip Mines, five hundred sixty-four thousand dollars (\$564,000).

(i) Two hundred eighty acres, Butler County, one hundred forty thousand dollars (\$140,000).

(ii) Sixty-five acres, Cambria County, thirty-two thousand dollars (\$32,000).

(iii) Four hundred seventy-one acres, Centre County, two hundred thirty-five thousand dollars (\$235,000).

(iv) Two hundred forty-five acres, Clearfield County, one hundred twenty-two thousand dollars (\$122,000).

(v) Fifty acres, Fayette County, twenty-five thousand dollars (\$25,000).

(vi) Twenty acres, Indiana County, ten thousand dollars (\$10,000).

Section 3. All moneys received from the Federal Government as contributions for such programs shall be paid into the General Fund and credited to this appropriation.

Section 4. This act shall take effect immediately.

AN ACT

SB 897

Making an appropriation to the State Treasurer from revenues received from all General Fund sources, except those received under the Tax Act of 1963 for Education, which are in excess of the estimated General Fund revenues available for appropriation from the 1964-1965 fiscal year as certified by the Secretary of Revenue and from the unappropriated surplus of all moneys lapsed from General Fund appropriations, to provide for the paying of salaries and wages of State officers and employes and other ordinary and general expenses in the interim between June 30, 1965 and such time as the funds provided by the General Appropriation Act and other appropriation acts become available and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1965.

Whereas, Under the Constitution and the laws of this Commonwealth, the State Treasurer may not pay out any moneys unless they be specifically appropriated by act of the General Assembly; therefore

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of forty-four million six hundred sixty-six thousand six hundred sixty-six dollars (\$44,666,666), or as much thereof as may be necessary, is hereby specifically appropriated to the State Treasurer of the Commonwealth of Pennsylvania from the unappropriated surplus of all revenues actually received from all General Fund sources during the fiscal period 1964-1965, except those received under the Tax Act of 1963 for Education, in excess of the estimated General Fund revenues available for appropriation from said sources for the same fiscal period as certified by the Secretary of Revenue and from the unappropriated surplus of all moneys lapsed from General Fund appropriations as of June 30, 1965. The funds thus appropriated for the purpose of paying the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the interim between June 30, 1965 and such time as moneys appropriated by the General Appropriation Act and other appropriation acts of 1965 may become available for such purposes; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1965.

Section 2. Payments out of the appropriation of this act shall be made by the State Treasurer upon requisitions by the several departments, boards, commissions or officers in the same manner as payments are ordinarily made.

Section 3. All amounts paid by the State Treasurer in accordance with this act shall be charged against the appropriations made for the

salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the General Appropriation Act and other appropriation acts of 1965.

Section 4. All amounts not expended from this appropriation at the time the General Appropriation Act of 1965 becomes effective shall automatically lapse.

Section 5. This act shall take effect immediately.

AN ACT

SB 898

Making appropriations to the Department of Public Welfare and providing for certain allocations therefrom for the purpose of carrying out the Public Assistance Law for the year beginning July 1, 1965 and for the payment of assistance and expenses accrued or incurred prior to and remaining unpaid on June 30, 1965.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of sixteen million six hundred sixty-six thousand six hundred sixty-six dollars (\$16,666,666), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for the payment of assistance and administrative expenses for the fiscal year beginning July 1, 1965 and for the payment of assistance and administrative expenses incurred prior to and remaining unpaid June 30, 1965, in the following amounts as shown:

(1) For county administration of the public assistance programs as provided in the acts of June 24, 1937 (P. L. 2017, 2045 and 2051), April 23, 1941 (P. L. 20), May 10, 1951 (P. L. 279), July 13, 1953 (P. L. 431), August 9, 1955 (P. L. 323), The Fiscal Code of 1929, The Penal Code of 1939 and the Public School Code of 1949 \$1,730,043

In addition to this amount, all moneys received from the Federal Government, or from any other source as contributions for this program, shall be paid into the General Fund and credited to this appropriation. The Department of Public Welfare shall allocate funds from time to time for administrative expenses of the several county boards of

assistance, for such administrative expenses incurred by the department which are chargeable to such boards and for the payment of attorney's fees and court costs necessary for the proper conduct of the public assistance programs.

(2) For assistance payments as provided in the acts of June 24, 1937 (P. L. 2017, 2045 and 2051), April 23, 1941 (P. L. 20), May 10, 1951 (P. L. 279), July 13, 1953 (P. L. 431), August 9, 1955 (P. L. 323), The Fiscal Code of 1929, The Penal Code of 1939 and the Public School Code of 1949

In addition to this amount all moneys received from the Federal Government or from any other source as contributions for this program shall be paid into the General Fund and credited to this appropriation. The Department of Public Welfare shall allocate funds from time to time for the several assistance programs. (Old Age Assistance, Aid to Dependent Children, Aid to Disabled, Blind Pension, General Assistance, Medical Services, Medical Assistance for the Aged, Purchased Hospital and Post-Hospital Care and other programs.) Provided, That any rule or regulation adopted by the Secretary of Public Welfare during the fiscal year 1965-66 which adds to the cost of any public assistance program including assistance payments, medical assistance to the aged and purchased hospital and post-hospital care, shall only be effective from and after the date upon which it is approved as to availability of funds by the Governor.

(3) For payment by quarterly allocation to the Department of the Auditor General in such amounts as may be deemed necessary for the administrative expenses of such department in auditing appropriations for or relating to public assistance, including any Federal sums supplementing such appropriations. Such allocations shall be made by the Governor, President Pro Tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the Auditor General, or a majority thereof

(4) For payment by quarterly allocation to the Treasury Department in such amounts as may be deemed necessary for the administrative expenses of such department in dis-

bursing appropriations for or relating to public assistance, including any Federal sums supplementing such appropriations. Such allocations shall be made by the Governor, President Pro Tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the State Treasurer or a majority thereof

AN ACT

SB 802

Making an appropriation to certain General Fund administrative departments, independent administrative boards and commissions and other agencies of the State Government and directing the Governor to make allocations thereof to provide for general pay increases for salaried and wage employes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of ten million seven hundred forty-nine thousand two hundred forty-eight dollars (\$10,749,248), or as much thereof as may be necessary, is hereby appropriated to those General Fund administrative departments, independent boards and commissions, and other agencies in the executive department of the State Government whose salaries and wages are fixed and standardized by the Executive Board, the State Council of Civil Defense, the State Tax Equalization Board, and the State Board of Parole for augmentation of all other appropriations made to said agencies for the purpose of providing funds for general pay increases to salaried and wage personnel.

Section 2. Upon the adoption of a compensation plan by the Executive Board revising classifications and guaranteeing to every state employe within section 1 hereof a five percent increase in wages and salaries, the Governor is directed to make such allocations from this appropriation in augmentation of their General Fund appropriations for the fiscal year beginning July 1, 1965, as may be necessary to provide funds therefor.

Section 3. This act shall take effect July 1, 1965.

AN ACT

SB 894

Making an appropriation out of the Motor License Fund to the Department of Public Instruction to promote highway safety education.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of thirteen thousand five hundred twenty-two dollars (\$13,522), or as much thereof as may be necessary, is hereby appropriated out of the Motor License Fund to the Department of Public Instruction for the fiscal year July 1, 1965, to June 30, 1966 for the purpose of promoting highway safety education through the schools in this Commonwealth.

Section 2. This act shall take effect July 1, 1965.

SB 431

Making an appropriation to the Treasury Department for the World War II Veterans' Compensation Sinking Fund to meet the sinking fund requirements of Series "N" bonds.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of thirteen million dollars (\$13,000,000), or as much thereof as may be necessary, is hereby appropriated to the Treasury Department for payment into the World War II Veterans' Compensation Sinking Fund to meet the sinking fund requirements of Series "N" bonds issued under authority of the act approved June 11, 1947 (P. L. 565), known as the "World War II Veterans' Compensation Act," and its amendments.

Section 2. This act shall take effect July 1, 1965.

AN ACT

SB 915

Making an emergency appropriation to the trustees of the University of Pittsburgh in order to pay a deficit for the general maintenance and operation of the university.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of two million five hundred thousand dollars (\$2,500,000), or as much thereof as may be necessary, is hereby appropriated to the trustees of the University of Pittsburgh, as an emergency appropriation, in order to pay a deficit, for the general maintenance of the University of Pittsburgh and for the purchase of such apparatus and equipment as the trustees may deem necessary for the best interest of the university. This sum shall be deducted from any other appropriation made to the University of Pittsburgh during the fiscal year beginning July 1, 1965.

Section 2. This act shall take effect immediately.

To provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt and for public schools for the fiscal year July 1, 1965, to June 30, 1966, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1965.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as "The General Appropriation Act of 1965."

Section 2. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the General Fund to the several hereinafter named agencies of the Executive, Legislative and Judicial Departments of the Commonwealth for the payment of the salaries, wages or other compensation and travel expense of the
