Making an appropriation from the State Employees' Retirement Fund to provide for expenses of the State Employees' Retirement Board for the fiscal year July 1, 1983 to June 30, 1984 and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$3,437,000, or as much thereof as may be necessary, is hereby specifically appropriated from the State Employees' Retirement Fund to the State Employees' Retirement Board for the fiscal year beginning July 1, 1983 and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983 for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the State Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983.

Section 2. Any additional funds necessary to fulfill contractual agreements for the management of investments is hereby appropriated.

Section 3. This act shall take effect July 1, 1983 or, if enacted subsequent to that date, then immediately.

SB 874

Making an appropriation from the Public School Employees' Retirement Fund to provide for expenses of the Public School Employees' Retirement Board for the fiscal year July 1, 1983 to June 30, 1984 and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$7,758,000, or as much thereof as may be necessary, is hereby specifically appropriated from the Public School Employees' Retirement Fund to the Public School Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the Public School Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 1983 and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983.

Section 2. This act shall take effect July 1, 1983 or, if enacted subsequent to that date, then immediately.

SB 875

Making an appropriation to the Department of Labor and Industry from the Workmen's Compensation Administration Fund to provide for the expenses of administering the Pennsylvania Workmen's Compensation Act and the Pennsylvania Occupational Disease Act for the fiscal year July 1, 1983 to June 30, 1984 and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$10,959,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of all salaries, wages and other compensation and travel expenses, for contractual services and other expenses necessary for the administration of the act of June 2, 1915 (P.L.736, No.338), known as The Pennsylvania Workmen's Compensation Act, and the act of June 21, 1939 (P.L.566, No.284), known as The Pennsylvania Occupational Disease Act, for the fiscal year beginning July 1, 1983 and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1983.

Section 2. This act shall take effect July 1, 1983 or, if enacted subsequent to that date, then immediately.

SB 880

Itemizing appropriations required from the Motor License Fund for the fiscal year July 1, 1983 to June 30, 1984 for the proper operation of the several departments of the Commonwealth authorized to spend Motor License Fund moneys.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as the Motor License Fund Appropriation Act of 1983.

Section 2. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the Motor License Fund to the hereinafter named agencies of the Commonwealth for the payment of salaries, wages and other compensation and travel expenses of the duly elected or appointed officers and employees of the Commonwealth, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities for the purposes hereinafter set forth for the fiscal period beginning July 1, 1983 and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1983.

The Motor License Fund budget I recommended for fiscal year 1983-84 was not much higher than last year's budget. However, due to reductions in motor fuel consumption, petroleum prices, and commercial vehicle travel, revenues in 1982-1983 were below original estimates. This trend is expected to continue in 1983-1984, necessitating the revenue measures I recommended. The General Assembly has not enacted the necessary revenue measures to fund this budget. Therefore, I must reduce the above items, including highway maintenance funds, to fit within the existing revenues of the Motor License Fund.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

PART I GENERAL PROVISIONS

Section 101. Short title.—This act shall be known and may be cited as the Supplemental General Appropriation Act for Fiscal Year 1983-1984.

Section 102. Definitions.—The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

“Employees.” Includes all directors, superintendents, bureau or division chiefs, assistant directors, assistant superintendents, assistant chiefs, experts, scientists, engineers, surveyors, draftsmen, accountants, secretaries, auditors, inspectors, examiners, analysts, statisticians, marshals, clerks, stenographers, bookkeepers, messengers and other assistants in any department, board or commission.

“Expenses” and “maintenance.” Includes all printing, binding and stationery, food and forage, materials and supplies, traveling expenses, training, motor vehicle supplies and repairs, freight, express and cartage, postage, telephones and telegraph rentals and toll charges, newspaper advertising and notices, fuel, light, heat, power and water, minor construction and renovation, repairs or reconstruction of equipment, buildings and facilities, rent of real estate and equipment, premiums on workmen’s compensation, insurance premiums on policies of liability insurance, insurance premiums on medical payment insurance and surety bonds for volunteer workers, premiums on employee group life insurance and employee and retired employee group hospital and medical insurance, payment of Commonwealth share of social security taxes and unemployment compensation costs for State employees, the purchase of replacement or additional equipment and machinery and all other incidental costs and expenses, including payment to the Department of General Services of mileage and other charges for the use of automobiles and rental payments for permanently assigned automobiles and of expenses or costs of services incurred through the Purchasing Fund. The term “expenses” also shall include the medical costs for the treatment of inmates of State institutions when the inmate must be transferred to an outside hospital: Provided, That in no case shall the State institution pay more for patient care than that provided under the State medical assistance program.

Unless otherwise stated, the appropriations include any carryovers from the prior fiscal year.

No county shall be reimbursed for costs above the actual direct costs, excluding capital outlays, incurred by them for the operation of all courts. For the purpose of reimbursement for appellate courts, the county shall receive 100% of the actual costs incurred for support of the appellate courts including those costs incurred but not reimbursed in fiscal years 1981-1982 and 1982-1983. For the purposes of reimbursement for common pleas court judge authorized positions, no county shall receive less than 75% of the actual reimbursement for court costs provided to them from funds appropriated for the fiscal year July 1, 1980 to June 30, 1981.

In addition, new focus may be placed on the unemployed, both old and new. Local agencies may lower their eligibility requirements for recipients to three months to allow greater flexibility to assure proper consideration of each recipient.

(b) The Community Services Block Grant amount, or as much thereof as may be necessary, is hereby specifically appropriated to the various hereinafter named departments of the Executive Department of the Com-

monwealth for the purposes, and under such restrictions, for which such block grant is provided for the fiscal year beginning July 1, 1983.

Section 702. Social Services Block Grant.—(a) The Social Services Block Grant is for the provision of social services to eligible persons.

(b) The Social Services Block Grant amount, or as much thereof as may be necessary, is hereby specifically appropriated to the various hereinafter named departments of the Executive Department of the Commonwealth for the purposes, and under such restrictions, for which such block grant is provided for the fiscal year beginning July 1, 1983.

(1) "Social Services Administration" - For administration and coordination of human resource activities of the Social Services Block Grant.

Source of funds.—In accordance with settlements of litigation brought by the United States Department of Energy against oil companies and refineries for alleged violations of the Federal Petroleum Price Allocation Regulations and the Further Continuing Appropriations Act of 1983, adopted by Congress in December, 1982 (House Joint Resolution 631), \$21,166,000 will be available to the Commonwealth for specific energy conservation programs through the fiscal year ending June 30, 1984.

Section 902. Appropriations.—The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the restricted receipt account, Oil Overcharge Settlements, to the several hereinafter named agencies of the Executive Department of the Commonwealth for the payment of expenses of implementing and carrying out the program stated herein for the fiscal year July 1, 1983 to June 30, 1984.

Section 903. Oil Overcharge Settlements Fund.—The appropriations provided to the Governor's Energy Council in items (1) and (2) of section 902 shall be fully funded from funds currently deposited in the restricted receipt fund for Oil Overcharge Settlements. As funds are received for deposit into this

restricted receipt fund, they shall be divided equally between the appropriation to the Governor's Energy Council for item (3) and the appropriation to the Department of Community Affairs for item (1), up to the maximum amount appropriated in this act.

PART X SPECIAL PROVISIONS FOR FEDERAL FUNDS

Section 1001. General Fund repository for Federal funds.—All moneys received from the Federal Government as contributions or supplements to the departments or agencies of the Commonwealth or the programs herein provided shall be paid into the General Fund and are hereby appropriated out of the General Fund for the purpose of the respective appropriations.

Section 1002. Limitation on encumbering or spending Federal funds.—Federal funds shall be encumbered or spent only to the extent that such funds are estimated as being available during the fiscal year of the Commonwealth.

Section 1003. Appropriation for prior unspent Federal funds.—Any Federal money which has been previously appropriated by the General Assembly and authorized or allocated by the Federal Government but remains unspent from prior fiscal years, and will not be renewed for fiscal year 1983-1984, is hereby appropriated.

Section 1004. Subgrants between Federal fund appropriations.—With the exception of Federal money received under the social services block grant, subgrants may be made between appropriations without further approval of the General Assembly. The Budget Secretary shall submit a list of subgrants to the Chairmen of the House and Senate Appropriations Committees quarterly. No subgrant to a State agency, however, may be made from a restricted receipt without a specific appropriation by the General Assembly.

Section 1005. Utilization of emergency Federal funds.—(a) Federal funds available for costs and damages resulting from natural disasters or civil disobedience may be added to an appropriation contained herein or to funds appropriated or may be used for the purposes prescribed by the Federal Government.

(b) In addition to the moneys appropriated by this act, all moneys received from the Federal Government for the purpose of disaster assistance or relief shall be paid into the General Fund and are hereby appropriated out of the General Fund to the departments, boards, commissions or agencies designated by the Governor.

(c) In the event of any emergency situation in which the General Assembly cannot act in sufficient time, the Governor is authorized through executive authorization to provide up to \$5,000,000 in Federal funds to alleviate the emergency situation. For the purposes of this section "emergency" is defined as any situation in which there is a chance of, or may result in, substantial human suffering.

PART XI
MISCELLANEOUS PROVISIONS

Section 1101. Prior law unaffected.—This act is not intended to be inconsistent with or to repeal any provision of any act enacted at this or any prior session of the General Assembly regulating the purchase of supplies, the ordering of printing and binding, the purchase, maintenance and use of automobiles, the method of making payments from the State Treasury for any purpose or the functioning of any administrative department, board or commission.

Section 1102. Compliance with other law before funds available.—No appropriation made by this act to any department, board, commission or agency of the Executive Department shall be available unless and until such department, board, commission or agency shall have complied with sections 615 and 616 of the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929.

Section 1103. Contracts prerequisite to encumbering or committing funds.—Purchase of supplies, materials and equipment shall not be deemed to be committed or encumbered until contracts covering said purchase have been entered into with the vendors.

Section 1104. Minority business set asides.—(a) Each department or other instrumentality of the Commonwealth listed in Part II, Subpart B, authorized to contract for buildings, highways, commodities, equipment, supplies or services shall report to the General Assembly all information pertinent to anticipated procurement needs at the beginning of each fiscal year and each fiscal quarter thereafter.

(b) As used in this section the term “minority business” means a minority business enterprise as defined in the act of July 22, 1974 (P.L.598, No.206), known as the Pennsylvania Minority Business Development Authority Act.

Section 1105. Appropriation of funds from miscellaneous sources.—

(a) In addition to the amounts appropriated by this act, moneys received in payment for food and household supplies furnished to employees and other persons, except inmates, by an institution, and moneys received from the proceeds from the sale of any products of the soil, meats, livestock, timber, or other materials sold by the department shall be paid into the General Fund and are hereby appropriated out of the General Fund to the several respective institutions for the operation and maintenance of said institutions.

(b) In addition to the amounts appropriated by this act, all moneys received from any other source, except the Federal Government, as contributions for the programs provided herein, or as payment for services or materials furnished by one institution to another, except those collections designated as revenues, shall be paid into the General Fund and are hereby appropriated out of the General Fund for the purposes of the respective appropriations.

(c) In addition to any funds specifically appropriated by this act, all moneys received by a department or agency of the Commonwealth from any

other sources, except the Federal Government, as contributions or supplements to the department or agency for a program or administration of an act included in this act shall be paid into the General Fund and credited to the appropriation for that program or administration of the act.

Section 1106. Lapsing of unused funds.—(a) Except as provided in subsections (b), (c) and (d), that part of all appropriations in Part II unexpended, uncommitted or unencumbered as of June 30, 1984 shall automatically lapse as of that date.

(b) The appropriations in Part II to the Department of Commerce for the various ports shall be continuing appropriations.

(c) The appropriation in Part II to the Department of Community Affairs for housing and redevelopment assistance shall be a continuing appropriation.

(d) The appropriations in Part II to the Legislative Department shall be continuing appropriations.

Section 1107. Credit for payments under prior law.—All amounts paid by the State Treasurer in accordance with the act of July 11, 1983 (No.2A), known as the General Appropriation Act of 1983, shall be charged against the appropriations made for the salaries and wages of the officers and employees and other ordinary and general expenses of the State Government in this act.

Section 1108. Construction of act.—Each appropriation without regard to monetary amount which is the same or similar to an appropriation in the act of July 11, 1983 (No.2A), known as the General Appropriation Act of 1983, shall replace and supersede such similar appropriation.

Section 1109. Repeals.—The following appropriations in the act of July 11, 1983 (No.2A), known as the General Appropriation Act of 1983 are repealed to the extent indicated:

Making appropriations from a restricted revenue account within the General Fund and from Federal augmentation funds to the Public Utility Commission.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$21,543,000, or as much thereof as may be necessary, is hereby appropriated from the restricted revenue account within the General Fund to the Public Utility Commission for the fiscal year July 1, 1983 to June 30, 1984, to provide for the operation of the commission.

Section 2. This act shall take effect immediately.

A SUPPLEMENT

HB 1023

To the act of April 1, 1863 (P.L.213, No.227), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making appropriations to Pennsylvania State University; providing for a basis for payments of the appropriations; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby appropriated to the Trustees of Pennsylvania State University, for the fiscal year July 1, 1983 to June 30, 1984, for the following purposes and amounts:

(1) For educational and general expenses and for participation by a representative of the institution, appointed by the Chief Executive Officer thereof, as a member of the Pennsylvania Academic Commission on Technological Development, a commission for inter-institutional communication regarding technological innovation and development and for dissemination of information on such matters to the Pennsylvania business community and others who may use such information for new business and job development in Pennsylvania, such commission to be composed of representatives of every State-owned or State-related educational or scientific institution receiving General Fund assistance from the Commonwealth.....	\$109,041,000
(2) For cost of student aid.....	1,760,000
(3) For cost of research.....	9,932,000
(4) For instruction - Doctor of Medicine only.....	3,160,000
(5) For cost of agricultural research.....	11,820,000
(6) For cost of agricultural extension services.....	10,002,000
(7) For cost of operating Elizabethtown Hospital.....	3,328,000
(8) For cost of soil survey.....	100,000
(9) To enhance the recruitment and retention of disadvantaged students.....	200,000
(10) For the purchase of services from the Buhl-Henderson Community Library of Sharon, Pennsylvania...	25,000

Section 2. Payments to Pennsylvania State University on account of the appropriations provided in section 1 shall be made on the basis of costs during the fiscal year.

Section 3. If necessary, Pennsylvania State University may transfer funds among the appropriations listed in section 1(1), (2), (3), (5) and (6). The aggregate amount transferred into or out of each appropriation during

the fiscal year shall not exceed 5% of the amount specifically appropriated for that purpose.

Section 4. (a) Payments to Pennsylvania State University of the appropriations provided in section 1 shall be made monthly during the fiscal year.

(b) The monthly payments shall be made in accordance with section 2 on the basis of estimated costs. The estimate of costs shall be submitted by the Pennsylvania State University to the Secretary of Education, the General Assembly and the State Treasurer not later than 30 days prior to the date on which the payment is to be made.

Section 5. Notwithstanding any provision of the General Appropriation Act of 1983 relating to the payment of retirement expenses, the Trustees of Pennsylvania State University shall make all required payments to the State Employees' Retirement Fund from the funds appropriated pursuant to this act.

Section 6. (a) Pennsylvania State University shall apply the moneys appropriated by this act only for the purposes permitted in this act and shall at all times maintain proper records showing the application of the moneys. Not later than 120 days after the close of the fiscal year to which this act relates, Pennsylvania State University shall file with the Secretary of Education, the General Assembly and the Auditor General a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during the fiscal year, as provided in section 2, used as a basis for receipt of any appropriation during the fiscal year.

(b) The statement of expenditures and costs shall be reviewed by the Auditor General who has the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Pennsylvania State University to the State Treasurer. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General has the right to review only and shall file annually with the General Assembly any information concerning these expenditures as the General Assembly or any of its committees may require.

Section 7. A report shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs except the Doctor of Medicine program. The report, to be submitted prior to September 1, 1984, shall cover the 12-month period beginning with the summer term 1983 and shall include:

(1) The following counts and distributions for each term during the period:

(i) The definitions and numbers of faculty members employed full-time, of faculty members employed part-time, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses and of part-time students enrolled in undergraduate courses.

(ii) The total numbers of undergraduate student credit hours, divided into lower division and upper division course levels and of graduate student

credit hours divided into three course levels: master's, first professional and doctoral.

(iii) The number of different courses scheduled by level of instruction and the number of sections of individual instruction at each level of instruction.

(iv) The number of terms scheduled and the dates thereof.

(2) For the summer term and the following academic year in total and for each two-digit Hegis category of instructional programs in higher education as defined by the National Center for Education Statistics, United States Department of Education, a classification of faculty members or other professional employees by title including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: teaching and non-teaching, with each set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time and the following aggregates for each subdivided classification:

(i) The number of faculty and other professional employees and their full-time equivalence in instructional and noninstructional functions.

(ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated; divided into lower division, upper division, master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated; divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from college or university funds, Federal funds and other funds.

(3) For each term of the period covered for each faculty member employed full-time identified by two-digit Hegis category and title, the report shall contain an analysis of the average hours per week spent in college or university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.

Section 8. (a) In addition to the requirements in section 7 relative to this appropriation, the report covering the 12-month period beginning with the summer term 1983 shall include for all programs of the university:

(1) The minimum number of credits required for a baccalaureate degree and for a master's degree.

HB 1027

Making appropriations to the Trustees of the University of Pennsylvania.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:
