Itemizing appropriations required from the Motor License Fund for the fiscal year July 1, 1985, to June 30, 1986, and additional appropriations for the fiscal year July 1, 1984, to June 30, 1985, for the proper operation of the several departments of the Commonwealth authorized to spend Motor License Fund moneys.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as the Motor License Fund Appropriation Act of 1985.

Section 2. The following sums, or as much thereof as may be necessary, are hereby appropriated from the Motor License Fund to the hereinafter named agencies of the Commonwealth for the payment of salaries, wages and other compensation and travel expenses of the duly elected or appointed officers and employees of the Commonwealth, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities for the purposes hereinafter set forth for the fiscal year beginning July 1, 1985, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985:

Making an appropriation from the State Employees' Retirement Fund to provide for expenses of the State Employees' Retirement Board for the fiscal year July 1, 1985, to June 30, 1986, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$5,020,000, or as much thereof as may be necessary, is hereby appropriated from the State Employees' Retirement Fund to the State Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the State Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 1985, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

Section 2. This act shall take effect July 1, 1985, or immediately, whichever is later.

Making an appropriation from the Public School Employees' Retirement Fund to provide for expenses of the Public School Employees' Retirement Board for the fiscal year July 1, 1985, to June 30, 1986, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$8,921,000, or as much thereof as may be necessary, is hereby appropriated from the Public School Employees' Retirement Fund to the Public School Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the Public School Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 1985, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

Section 2. This act shall take effect July 1, 1985, or immediately, whichever is later.

Making appropriations to the Department of Labor and Industry from the Workmen's Compensation Administration Fund to provide for the expenses of administering The Pennsylvania Workmen's Compensation Act and The Pennsylvania Occupational Disease Act for the fiscal year July 1, 1985, to June 30, 1986, for increasing the complement level of Workmen's Compensation Referees, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$11,213,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of all salaries, wages and other compensation and travel expenses, for contractual services and other expenses necessary for the administration of the act of June 2, 1915 (P.L.736, No.338), known as The Pennsylvania Workmen's Compensation Act, and the act of June 21, 1939 (P.L.566, No.284), known as The Pennsylvania Occupational Disease Act, for the fiscal year beginning July 1, 1985, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

Section 2. The sum of \$470,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of salaries, wages and other compensation and travel expenses necessary for increasing the filled complement level of Workmen's Compensation Referees to 50 and for the additional personnel and operating costs necessary to support this increase.

Section 3. This act shall take effect July 1, 1985, or immediately, whichever is later.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

PART I
GENERAL PROVISIONS

Section 101. Short title.—This act shall be known and may be cited as the Pennsylvania Economic Revitalization Fund Appropriation Act of 1985.

Section 102. Pennsylvania Economic Revitalization Fund.—The following sums set forth in this act, or as much thereof as may be necessary, are hereby specifically appropriated from the Pennsylvania Economic Revitalization Fund to the several hereinafter named agencies of the Executive Department of the Commonwealth for the payment of fees of contractual services rendered, for the purchase or rental of goods, services and for payment of any other expenses, as provided by law or by this act, necessary for the proper conduct of the duties, functions and activities and for the purposes hereinafter set forth for the fiscal year beginning July 1, 1985, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1985.

PART II
PENNSYLVANIA ECONOMIC REVITALIZATION FUND

Section 201. Department of Commerce.—The following amounts are appropriated to the Department of Commerce:

Section 202. Department of Environmental Resources.—The following amounts are appropriated to the Department of Environmental Resources:

Section 301. Construction of act.—Any appropriation in section 202, which is the same as or similar to an appropriation in section 12 of the act of July 2, 1984 (P.L.561, No.112), known as the Pennsylvania Conservation Corps Act, shall replace that appropriation. All funds expended or encumbered under the replaced appropriation shall be credited against the appropriation in section 202.

Making an appropriation from a restricted revenue account within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$8,763,000, or as much thereof as may be necessary, is hereby appropriated from the Professional Licensure Augmentation Restricted Revenue Account within the General Fund to the Department of State for the operation of the Bureau of Professional and Occupational Affairs for the fiscal year July 1, 1985, to June 30, 1986. This appropriation shall not be treated as an augmentation to the Department of State general government appropriation or any other appropriation, but shall be treated and accounted for as a separate appropriation.

Section 2. This act shall take effect July 1, 1985, or immediately, whichever is later.

A SUPPLEMENT

HB 1251

To the act of April 1, 1863 (P.L.213, No.227), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In order to carry into effect the act of Congress, approved July 2, 1862, granting public land to the several states for educational purposes, and subsequent acts of Congress related thereto, and the act of the General Assembly of Pennsylvania accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the following sums, or as much thereof as may be necessary, are hereby appropriated to the Trustees of The Pennsylvania State University for the fiscal year July 1, 1985, to June 30, 1986, for the purposes and in the amounts as shown:

- (1) For educational and general expenses and for participation by a representative of the institution, appointed by the chief executive officer thereof, as a member of the Pennsylvania Academic Commission on Technological Development, a commission for interinstitutional communication regarding technological innovation and development and for dissemination of information on such matters to the Pennsylvania business community and others who may use such information for new business and job development in Pennsylvania, such commission to be composed of representatives of every State-owned or State-related educational or scientific institution receiving General Fund assistance from the Commonwealth..... \$128,269,000
- (2) For cost of research..... 11,211,000
- (3) For instruction - Doctor of Medicine only..... 3,567,000
- (4) For cost of agricultural research..... 13,343,000
- (5) For cost of agricultural extension services..... 11,291,000
- (6) For the cost of operating Elizabethtown Hospital... 3,757,000
- (7) To enhance recruitment and retention of disadvantaged students..... 200,000

Section 2. Payments to The Pennsylvania State University on account of the appropriations for all items as provided in section 1 shall be made on the basis of costs during the fiscal year.

Section 3. If necessary, The Pennsylvania State University may transfer funds among the appropriations listed in section 1(1), (2), (4) and (5): Pro-

vided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed 5% of the amount specifically appropriated for that purpose.

Section 4. (a) Payments to The Pennsylvania State University of the appropriations provided in section 1 shall be made monthly during the fiscal year.

(b) Such monthly payments shall be made in accordance with the provisions of section 2 on the basis of estimated costs. The estimate of costs shall be submitted by The Pennsylvania State University to the Secretary of Education, the General Assembly and the State Treasurer not later than 30 days prior to the date on which such payment is to be made.

Section 5. Notwithstanding any provision of the General Appropriation Act of 1985 relating to the payment of retirement expenses, the Trustees of The Pennsylvania State University shall make all required payments to the State Employees' Retirement Fund from the funds appropriated pursuant to this act.

Section 6. (a) The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 120 days after the close of the fiscal year to which this act relates, The Pennsylvania State University shall file, with the Secretary of Education, the General Assembly and the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, as provided in section 2, used as a basis for receipt of any appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by The Pennsylvania State University to the State Treasurer. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Section 7. A report shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs except the Doctor of Medicine program. The report, to be submitted prior to September 1, 1986, shall cover the 12-month period beginning with the summer term 1985 and shall include:

(1) The following counts and distributions for each term during the period:

(i) The definitions and numbers of faculty members employed full time, of faculty members employed part time, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses and of part-time students enrolled in undergraduate courses.

(ii) The total numbers of undergraduate student credit hours, divided into lower division and upper division course levels, and of graduate student credit hours divided into three course levels—master's, first professional and doctoral.

(iii) The number of different courses scheduled by level of instruction and the number of sections of individual instruction scheduled by level of instruction, each further subdivided by two-digit Classification of Instructional Program (CIP) categories of instructional programs of higher education as defined by the National Center for Education Statistics, United States Department of Education.

(iv) The number of terms scheduled and the dates thereof.

(2) For the summer term and the following academic year in total and for each two-digit CIP program category, a classification of faculty members or other professional employees by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: teaching and non-teaching, and each such set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time and the following aggregates for each such subdivided classification:

(i) The number of faculty and other professional employees and their full-time equivalence in instructional and noninstructional functions.

(ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from university funds, Federal funds and other funds.

(3) For each term of the period covered for each faculty member employed full time identified by two-digit CIP program category and title, the report shall contain an analysis of the average hours per week spent in university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.

Section 8. In addition to the requirements in section 7 relative to this appropriation, the report covering the 12-month period beginning with the summer term 1985 shall include for all programs of the university:

(1) Minimum number of credits required for a baccalaureate degree and for a master's degree.

(2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in 1983, 1984, 1985 and estimated 1986.

- (2) For dental clinics..... 849,000
- (3) For instruction in the Doctor of Medicine program.. 3,658,000
- (4) For instruction in Veterinary Medicine programs only..... 6,371,000
- (5) For the New Bolton Animal Center..... 2,842,000
- (6) For food and animal clinics and services..... 1,580,000

Section 2. Payments to the University of Pennsylvania on account of the appropriations for the items provided in section 1 shall be made quarterly by the Secretary of Education on the basis of costs during the fiscal year.

(a) Bridge housing.—The sum of \$2,000,000 is hereby appropriated to the Department of Public Welfare for the fiscal year 1985-1986 for the creation and operation of bridge housing facilities for the homeless. Bridge housing facilities shall provide short-term housing and access to appropriate supportive services such as health care, social services, education and job training to enable domestic violence victims, unemployed adults, substance abusers or other low-income individuals to achieve self-sufficiency.

(b) Single-room occupancy housing.—The sum of \$3,500,000 is hereby appropriated to the Department of Community Affairs to establish low-cost single-room occupancy housing facilities for homeless and other low-income individuals through renovation of existing buildings. Single-room occupancy housing facilities shall have cooperative arrangements with community health and social service agencies to meet the needs of chronically mentally ill individuals and other populations with special needs. This appropriation shall not lapse until June 30, 1987.

Section 2. Effective date.

This act shall take effect immediately.
