## AN ACT

Supplementary to an act, entitled "An act to authorise the Governor to incorporate a company for making an artificial road by the nearest and best route, through the counties of Wayne and Luzerne, beginning at the river Delaware, where the proposed bridge is to be built, near the town of Milford, thence through the said town, and the counties aforesaid, to or near the forty-third mile stone, on the north line of the state," and for other purposes.

**SECT. 1.** *Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same,*

That the president, managers and company of the Milford and Owego turnpike road, be and they are hereby authorised to extend and construct a branch or lateral turnpike road, as follows; to wit: beginning on the Milford and Owego turnpike road, at or near the town of Dundaff, in Susquehanna county, thence to Carbondale, in Luzerne county, and thence to intersect the said Milford and Owego turnpike road, at the most convenient point east of the Lackawanna creek, under the same rules, regulations and restrictions contained in the charter of the said company, and with the same rights, liberties, privileges and powers now enjoyed and exercised by the said company, over and upon the said Milford and Owego turnpike road.

Milford and Owego company may construct a lateral road.

**WHEREAS,** The commissioners appointed in the first section of the act entitled "A supplement to an act entitled An act to authorise the Governor to incorporate the Dundaff and Tunkhannock and other turnpike road companies, and for other purposes," passed the tenth April, eighteen hundred and twenty-eight, in receiving subscriptions for stock, instead of demanding and receiving the payment of two dollars and fifty cents on each share, at the time of subscribing, took notes for the payment of the same, by reason whereof a charter cannot be obtained for the company therein mentioned:

**SECT. 2.** *Be it further enacted by the authority aforesaid,* That the commissioners or a majority of them named in the first section of an act entitled "An act to authorise the Governor to incorporate the Dundaff and Tunkhannock and other turnpike road companies, and for other purposes," be and they are hereby authorised, on or before the first day of October next, to re-open the books for receiving subscription to the stock of the Dundaff and

Commissioners for Dundaff & Tunkhannock road may re-open books for subscribing stock.

Tunkhannock turnpike road company, upon the same terms, under the same rules and regulations, and with the same force and effect, as are prescribed and granted by the act to which this is a supplement.

AN ACT

To authorise the Governor to incorporate the president, managers and company of the Indiana and Kiskiminetas turnpike road.

SECT. 1. *Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same,* That John Taylor, Leonard Shryock, William Trimble, Alexander Patterson, of Indiana county, and David Leech and Thomas Sharp, of Armstrong county, be and are hereby appointed commissioners to do and perform the several things hereinafter mentioned, that is to say, they shall on or before the first day of July next, procure two books and enter in them as follows: "We whose names are hereunto subscribed, do promise to pay unto the president, managers and company of the Indiana and Kiskiminetas turnpike road the sum of twenty-five dollars for every share of said stock set opposite to our respective names, in such manner and proportions and at such times as shall be determined on by the president and managers of the said company, in pursuance of an act of the general assembly of this commonwealth, entitled "An act to authorise the Governor to incorporate the president, managers and company of the Indiana and Kiskeminetas turnpike road," as witness our hands the day of                    in the year of our Lord one thousand eight hundred and                   ," and shall there-
