A FURTHER SUPPLEMENT

To the act entitled "An act to regulate the general elections within this commonwealth," passed the fifteenth day of February, one thousand seven hundred and ninety-nine, as relates to the county of Crawford.

SECT. 1. *Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same,* That from and after the passage of this act, at all general and special elections to be hereafter held in the county of Crawford, in each and every election district in said county, the number of the judges of said elections shall not exceed three, and their clerks two.

AN ACT

For the relief of Jesse Smith, of Bradford county.

WHEREAS, It is represented to the legislature, by the memorial and petition of sundry inhabitants of the county of Bradford, that in the year one thousand eight hundred and twenty, Jesse Smith, of said county, was tried and wrongfully convicted at a court of quarter sessions in said county of Bradford, at the December term of said year, on an indictment for malicious mischief, and that he was thereupon sentenced to pay a

fine, the costs of prosecution, and undergo an imprisonment in the jail of said county, and that in pursuance of said sentence, the said Jesse Smith was compelled to pay said costs, and undergo an imprisonment for almost nine months, and incurred considerable other expenses, all of which was manifestly unjust :

Therefore,

SECT. 1. *Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same,* That the county commissioners of Bradford county be and they are hereby authorised and required to adjust and settle the reasonable claims of the said Jesse Smith, for the costs and expenses which he has been obliged to pay, in pursuance of his conviction and sentence on the said indictment, and allow him such amount as they shall adjudge just and right, which amount, after having been approved by the auditors of said county, shall be paid by order or orders drawn in the usual manner on the treasurer of said county of Bradford.
