RESOLUTION

To correct a mistake made in the act, entitled "An Act to appropriate certain unseated land taxes in the county of Bradford," passed the eighteenth day of March, one thousand eight hundred and forty-four.

WHEREAS, In the act of assembly entitled "An Act to appropriate certain unseated land taxes in the county of Bradford," passed the eighteenth day of March, one thousand eight hundred and forty-four, the lands therein referred to, are mentioned as "owned and known as the estate of Isaac Barekley," instead of Robert Barekley, to whose estate said lands belong: Therefore, Preamble.

Resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the name Isaac Barekley, in said act, be changed, and the same is hereby changed to Robert Barekley, and said act made applicable to the unseated tracts of land owned and known as the estate of the heirs of Robert Barekley, to have the same force and effect as if the name Robert Barekley were mentioned in said act of eighteenth March, one thousand eight hundred and forty-four, instead of Isaac Barekley.

RESOLUTIONS

In relation to the navigation of the river Delaware.

WHEREAS, The piers erected in the river Delaware, at or near Port Penn, for the security of vessels during the existence of storms or ice, have become so much impaired as, in a great measure, to fail of the object contemplated by their erection: *And whereas*, In consequence of their defective and dilapidated condition, heavy losses have already accrued, as well to citizens of this commonwealth as to those of other states concerned in navigation and commerce: *And whereas*, A moderate appropriation, if timely and judiciously applied, would be sufficient to render the navigation of said river comparatively safe at all seasons: Therefore, Preamble.

Resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That our senators and representatives in congress be and they are hereby requested to use their efforts and influence to procure an early appropriation for repairing or re-building said piers, and for the erection of such additional piers or other devices as may be deemed expedient, to afford adequate shelter and protection to vessels navigating the river Delaware during the existence of storms or ice.

Resolved, That the governor be requested to transmit a copy of the above preamble and resolutions to each of our senators and representatives in congress.

RESOLUTION

For re-auditing the accounts of Erastus Hill.

Resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the auditor general is hereby required to re-examine and re-audit the accounts of Erastus Hill, river commissioner for clearing out the Susquehanna river between Northumberland and Wilkesbarre, in the year one thousand eight hundred and twenty-three: and that if said account, as then rendered and certified and now in the auditor general's office, shall appear to be just and equitable, to cause the same to be credited to said Hill's account on the books of the department: *Provided,* That there be no money drawn from the treasury on account thereof.
