## AN ACT

Regulating the payment of constables' fees for conveying paupers in Franklin county.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That from and after the passage of this act, the fees to be received by constables in the county of Franklin, for the removal of paupers from any part of said county to the poor house of the same, shall be as follows, viz: For travelling expenses for the removal of one pauper, or where more than one shall be included in the same order of removal, for each mile circular, six cents. In all cases in which there is more than one order executed by any constable at the same time, for the first order five cents for each mile circular, for the second four cents, for the third three cents, and for any additional number of orders above three, executed at the same time, no mileage shall be allowed.

SECTION 2. That so much of the eleventh section of the act to which this is a supplement, as is hereby altered or supplied, be and the same is hereby repealed.

## AN ACT

Authorizing the sale of an acre of ground of the estate of Jacob Groff, dec'd, in West Earl township, Lancaster county, to trustees of "Groff's Meeting House," in said township.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That Abraham Haverstick, of Conestoga township, Lancaster county, in behalf of his wife who was the widow, and in behalf of the heirs of Jacob Groff, late of West Earl township, in said county, deceased, is hereby Power to sell.

authorized to sell and convey to Michael Wenger, Christian Oberholzer and John Huber, or their successors, trustees for the Menonist meeting house called "Groff's Meeting House," in said township of West Earl, one acre off the northern end of the tract of about twenty-four acres of said Jacob Groff, deceased; for the sum of one hundred and twenty dollars, the interest of which sum to be paid to Leah Haverstick, late Leah Groff, for life, and at her death the said sum of one hundred and twenty dollars, to be paid to such persons to whom the remainder of said tract will by law descend.

Security.

SECTION 2. That before said conveyance, Abraham Haverstick shall give security, to be approved of by the court of common pleas of Lancaster county, for the faithful appropriation of the said one hundred and twenty dollars, in the manner mentioned in the first section of this act.

# AN ACT

To authorize James Clarke to construct a dam in the Conemaugh river.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That James Clarke, of the borough of Blairsville, county of Indiana, be and is hereby authorized to erect a dam, not exceeding six feet in height, over the Conemaugh river, at or near Clarke's Fording, about four miles above Blairsville, in the county of Indiana, in such manner as shall do no damage to either public or private property: *Provided, however,* That a plan and location of said dam shall be first approved by the canal commissioners, and shall be erected within seven years after the passage of this act.
