A SUPPLEMENT

To an act passed the thirteenth day of January, eighteen hundred and ten, entitled
 "An Act to incorporate the Bible society of Philadelphia."

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the officers of the said society, (now called the Pennsylvania Bible society) elected according to the provisions of the act to which this is a supplement, or of any other supplement thereto, shall be associated with the managers in the direction of the affairs of the society, and entitled to all the rights and privileges of managers in transacting its business, and shall jointly with them constitute the board of managers.

SECTION 2. That the board of managers may, at any stated meeting, fill any vacancy which may occur in their own body, whether of officers or managers.

SECTION 3. That the board of managers may, at their discretion, use and appropriate the funds, income and revenue of the society, in curing and distributing the scriptures of the Old and New Testaments, in such manner as they shall deem most beneficial.

AN ACT

Relative to roads and bridges in the township of Warsaw, Jefferson county.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the provisions of the first fourteen sections, together with the sixteenth and last six sections, and the insertion of the words twelve citizens which are hereby substituted, instead of fifty citizens in the eighth section of an act, entitled "An Act relative to roads and bridges in the counties of Armstrong, Mercer and Crawford," passed the third day of

Certain act extended to Warsaw township, Jefferson county.

April, eighteen hundred and forty-six, be and they are hereby extended to the township of Warsaw, in Jefferson county.

Former acts repealed.

SECTION 2. All other acts, so far as they relate to roads and bridges in the township of Warsaw, Jefferson county, as are hereby altered or supplied, be and the same are hereby repealed.

AN ACT

To authorize Regina Scholl and her son John D. Scholl, of Lehigh county, to sell certain real estate.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That Authority to sell. Regina Scholl and her son John D. Scholl, of Lehigh county, be and they are hereby authorized to sell and convey in fee simple, at public sale, all that messuage, tenements and three tracts of land, situate in Heidelberg township, Lehigh county, as described in the will of Henry Scholl, deceased, and to invest the proceeds thereof, under the direction of the orphans' court of Lehigh county, in other more productive real estate, or place the same upon interest on real security, as may be deemed most proper to carry into effect the last will and testament of the said Henry Scholl, deceased: *Provided,* That before this said sale shall take place, the said Regina Scholl and John D. Scholl shall give security, to be approved by the said court, for the faithful application of the proceeds of said sale, agreeably to the desire of said deceased.
