To annul the marriage contract between Frederick W. Martens and Mary C. W.,

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That* the marriage contract entered into between Frederick W. Martens, of the city of New York, and Mary C. W., his wife, be and the same is hereby declared null and void, and the parties discharged from all the obligations and liabilities growing out of the same, as fully and absolutely as if they had never been joined in marriage, and that her parental name be restored to her, to wit: Mary Caroline Wilber.
