the proceedings of said officers in a minute book in which he shall also record all court orders relative to the laying out, opening and vacating of roads. The minute book, account book and other financial records shall be carefully preserved by the secretary and shall be turned over to his successor in office. Miscellaneous records and papers of the township other than the minute book and account book may be destroyed with the consent of the supervisors after the lapse of six years from the date of such records.

The secretary shall prepare and write the annual tax duplicate of the township, and shall receive such salary, wages or other compensation therefor as shall be fixed by the township supervisors. The combined amount paid to the secretary and treasurer as salary, wages or other compensation for services, exclusive of the compensation for preparation of the annual tax duplicate, shall not exceed three per centum of the money paid out by the treasurer, but it shall not be less than [fifty] seventy-five dollars per annum, and the calculation of such maximum compensation shall not include any percentage upon moneys paid out by the treasurer for the repayment of loans, notes, certificates, or other evidences of indebtedness, or other borrowed moneys.

The secretary shall inform all members of the board of supervisors of all functions and meetings, including special meetings of the board. Section 2. This act shall take effect immediately.

SB 412

Authorizing any county of the third class to make an appropriation for the observance and celebration of the Civil War Centennial.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Any county of the third class may appropriate a sum not exceeding one thousand dollars (\$1,000) for the observance and cele-

bration of the one hundredth anniversary of the end of the Civil War. Section 2. This act shall take effect immediately.

AN ACT

HB 375

Providing for the observance of April 15 of each year as Local Government Day.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Governor shall issue, annually, his proclamation designating and setting apart April 15 as Local Government Day and calling upon the citizens of the Commonwealth to recognize the vital role of local government, including municipalities and school districts, in the preservation of our heritage of freedom, justice, equality and self-government, and to remind the people that unless every individual citizen takes an active interest and assumes responsibility in his local government, there can be real danger he will be losing control to the State and Federal government over problems which he knows best, such as public education, health and safety.

Section 2. This act shall take effect immediately.

SB 140

Amending the act of August 20, 1953 (P. L. 1217), entitled "An act providing for payments by the Commonwealth to municipalities which have expended money to acquire and construct sewage treatment plants in accordance with the Clean Streams Program and the act, approved the twenty-second day of June, one thousand nine hundred thirty-seven (Pamphlet Laws 1987), and making an appropriation," requiring payments of two per centum by the Commonwealth to municipalities and authorities on account of sewage treatment plants.
