shall be appointed by the Governor, on or before the effective date of this act, and shall hold their office until the third Tuesday of January, one thousand nine hundred and forty-seven, or until their successors shall have been appointed and qualified, as provided by law. The four members to be appointed, as aforesaid, who are not members of the present Pennsylvania Historical Commission shall be chosen from sections of the Commonwealth not represented by the five members who are now members of the Pennsylvania Historical Commission.

The members of the General Assembly shall be appointed by the President pro tempore of the Senate and the Speaker of the House of Representatives, respectively, for a term to expire with his concurrent term as a legislator, and shall serve until his successor is appointed and qualified, unless he shall not be elected for the next succeeding term as a member of the General Assembly, in which case a vacancy shall occur.

Members, other than members of the General Assembly, shall serve

for a term of four years and each shall serve until his successor is appointed and qualified.

HB 627

Amending the act of August 31, 1955 (P. L. 531), entitled "An act permitting and regulating wrestling and boxing contests and exhibitions; requiring licenses and permits; conferring powers and imposing duties upon the State Athletic Commission; providing for the granting, suspension and revocation of licenses and permits issued by the Commission; preserving the rights of existing licensees and permittees; prescribing penalties, fines, forfeitures and misdemeanors; requiring bonds and insurance; creating a Medical Advisory Board; providing for rules and regulations; and making appropriations," requiring physical examinations at the expense of promoters of boxers following contests or exhibitions in which they participate.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 205, act of August 31, 1955 (P. L. 531), known as the "Pennsylvania Athletic Code," amended May 24, 1956 (P. L. 1693), is amended to read:

[&]quot;Sction" in original.

Section 205. Examinations.—In addition to any other examination required by this act or the rules and regulations promulgated hereunder, each boxer or wrestler must be examined by the attending physician within two (2) hours before he enters the ring. If, in the opinion of the physician, any boxer or wrestler is physically or mentally unfit to proceed, the physician shall forthwith notify any commissioner or the deputy in charge who shall immediately cancel the contest or exhibition.

This required examination shall conform to the rules and regulations promulgated hereunder pursuant to the advice of the Medical Advisory Board.

In addition to the examination required herein, every boxer shall be examined by a physician designated by the Commission during the five (5) days following every contest or exhibition in which he was a participant. Such examination shall be performed at the expense of the promoter.

The results of the [examination] examinations required by this section shall be reduced to writing by the physician, signed by him and filed with the Commission within forty-eight (48) hours after [the termination of the contest or exhibition] they have been performed.

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," exempting from registration, certain self-propelled golf carts.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 401, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," is amended by adding after subsection (f), a new subsection to read:

Section 401. Registration of Motor Vehicles, Tractors, Trailers and Semi-Trailers Required; Special Permits for Nonresidents.—
