the Commonwealth, courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to elections," providing for the setting aside of certain nominations made at the primary or by nomination papers.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The act of June 3, 1937 (P. L. 1333), known as the "Pennsylvania Election Code," is amended by adding after section 922, a new section to read:

Section 922.1. Setting Aside Nominations of Candidates.—With respect to any office that was in existence on the thirteenth Tuesday before the primary and for which nominations were made at the primary or by nomination papers, whenever it shall appear that said office has been abolished in accordance with any act of assembly or legal proceeding, the county board of elections shall set aside all nominations made for any such office and shall remove such office block affected, if any, from the ballots or ballot labels for the ensuing November election.

Section 2. This act shall take effect immediately.

## AN ACT

HB 722

Authorizing the Department of Highways to conduct a study and survey to determine the advisability of establishing, constructing and maintaining a State highway in Lackawanna County for the purpose of encouraging industrial development therein.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Highways is hereby empowered, and its duty shall be, to conduct a study and survey in order to determine the advisability of establishing, constructing and maintaining a State highway between Dunmore Industrial Park through the Boroughs of Throop, Olyphant, Jessup, Archbald, Jermyn, Mayfield and Carbondale City and township in Lackawanna County, beginning and ending at such

points as the Department of Highways shall elect. In such study and survey, due regard shall be had for the necessity and importance of such a State highway from a traffic viewpoint as well as the consideration of cost and feasibility of the State highway at such location and present means of ingress and egress from the localities involved and for the purpose of encouraging industrial development therein.

Section 2. This act shall take effect immediately.

## AN ACT

SB 266

Amending the act of April 9, 1929 (P. L. 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions and officers; fixing the salaries of the Governor, Lieutenant Governor and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," removing the limitation upon the time during which the Executive Board may grant additional sick leave with pay in certain special cases and otherwise changing provisions relating to leaves and holidays for certain State employes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsections (b), (c) and (d) of section 222, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," amended August 24, 1961 (P. L. 1126), are amended to read:

Section 222. Work-Hours and Leaves.—\* \* \*

(b) Each salaried employe of such department, board or commission shall be entitled each calendar year to a number of days' annual leave of absence with full pay equal to three times the number of working days in such employe's normal work week. Each hourly or per diem employe of such department, board or commission shall be entitled to one day's annual leave of absence with pay for each one hundred and forty (140) hours such employe shall work.
