Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," further providing for registration of motor vehicles excepting certain title requirements as to farm tractors.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (a) of section 401, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," is amended to read:

Section 401. Registration of Motor Vehicles, Tractors, Trailers and Semi-Trailers Required; Special Permits for Nonresidents.—

(a) Except as is hereinafter provided, no motor vehicle, tractor, trailer or semi-trailer shall be operated upon any highway in this Commonwealth until such vehicle or tractor shall have been properly registered with the department, as hereinafter provided, and the registration plate or plates that have been issued for the vehicle or tractor for the current year are received and displayed as required by this act, and no such vehicle, except a farm tractor, shall be registered until a certificate of title has been obtained therefor.

* * *

Penalty.—Any person violating any of the provisions of this section, shall, upon summary conviction before a magistrate, be sentenced to pay a fine of ten dollars (\$10.00) and costs of prosecution, and, in default of the payment thereof, shall undergo imprisonment for not more than five (5) days.

Amending the act of May 5, 1933 (P. L. 364), entitled "An act relating to business corporations; defining and providing for the organization, merger, consolidation, reorganization, winding up and dissolution of such corporations; conferring certain rights, powers, duties and immunities upon them and their officers and shareholders; prescribing the conditions on which such corporations may exercise their powers; providing for the inclusion of certain existing corporations of the second class within the provisions of this act; prescribing the terms and conditions upon which foreign business corporations may be admitted, or may continue, to do business

within the Commonwealth; conferring powers and imposing duties on the courts of common pleas, and certain State departments, commissions, and officers; authorizing certain State departments, boards, commissions, or officers to collect fees for services required to be rendered by this act; imposing penalties; and repealing certain acts and parts of acts relating to corporations," requiring approval by the State Registration Board for Professional Engineers prior to the use of certain words in corporate names.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 202, act of May 5, 1933 (P. L. 364), known as the "Business Corporation Law," is amended by adding after subsection D. (1). a new subsection to read:

Section 202. The Corporate Name.—

* * *

D. (2). The corporate name shall not contain the words "engineer" or "engineering" or "surveyor" or "surveying," or any other word implying that any form of the practice of engineering or surveying, as defined in the act of May 23, 1945 (P. L. 913), known as the "Professional Engineers Registration Law," is provided, unless the use of such name shall first have been approved by the State Registration Board for Professional Engineers and there is submitted a certificate from the board that the corporation or proposed corporation is entitled to use such designation in its corporate name.

Section 2. The State Registration Board for Professional Engineers shall approve the corporate name, provided, that at least one of the incorporators of the business corporation has been properly registered with said board in the practice of engineering or surveying.

Section 3. The provisions of this act shall not affect the use of any corporate name authorized prior to the effective date of this act.

Section 4. This act shall take effect immediately.
