

work without remuneration: Provided, That the said garage or other farm is within eight miles of the farm or farms which the owner or operator of the vehicle owns or operates. Vehicles exempt from registration may also be operated on the highways between such farm or farms and any place or places for the buying or selling of farm products located within eight miles of the farm or farms which the owner or operator of the vehicle owns or operates.

AN ACT

HB 1060

Amending the act of April 29, 1937 (P. L. 487), entitled, as amended, "An act to provide for the permanent personal registration of electors in cities of the second class, cities of the second class A, cities of the third class, boroughs, towns, and townships as a condition of their right to vote at elections and primaries, and their enrollment as members of political parties as a further condition of their right to vote at primaries; prescribing certain procedure for the conduct of elections and primaries and the challenge and proof of qualifications of electors; requiring the county commissioners of the various counties to act as a registration commission therefor; and prescribing the powers and duties of citizens, parties, political bodies, registration commissions, commissioners, registrars, inspectors of registration and other appointees of registration commissions, county election boards, election officers, municipal officers, departments and bureaus, police officers, courts, judges, prothonotaries, sheriffs, county commissioners, peace officers, county treasurers, county controllers, registrars of vital statistics, certain public utility corporations, real estate brokers, rental agents, and boards of school directors; and imposing penalties," making it illegal to give money or goods to a person to induce him to register in a particular party or to change his party enrollment and providing penalties.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (1) of section 44, act of April 29, 1937 (P. L. 487), known as "The Permanent Registration Act for Cities of the Second Class, Cities of the Second Class A, Cities of the Third Class, Boroughs, Towns, and Townships," reenacted and amended May 31, 1955 (P. L. 62), is amended to read:

Section 44. Crimes and Penalties.—* * *

(1) Any registrar, commissioner, clerk, assistant or employe of a commission, or any other person, who knowingly and wilfully prevents a

person from being registered, or who, by coercion, threats of bodily injury or intimidation, prevents or attempts to prevent any person from being registered or from changing his political enrollment in accordance with the provisions of this act, or who gives, or promises or offers to give, any gift or reward in money or, goods to any person to enroll in a particular party or to change his political enrollment, shall be guilty of a misdemeanor, and, upon conviction thereof, shall be sentenced to pay a fine not exceeding one thousand dollars (\$1000), and to undergo an imprisonment of not less than three (3) months nor more than five (5) years.

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 7.4203 acres, more or less, of land situate at Thompsettown, Juniata County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized, on behalf of the Commonwealth of Pennsylvania, to sell to the borough of Thompsettown to be used for public park or municipal purposes or industrial development or other public uses, as determined by the borough council, for a consideration of one dollar (\$1), the following described parcel of land together with all improvements thereon, situate at Thompsettown, Juniata County, Commonwealth of Pennsylvania:

All that certain parcel of land:

Beginning at a stake on the northern side of a 15 foot wide alley which point is 25 feet on a line having a bearing of north 79 degrees and 29 minutes east from the center line of State Highway Legislative Route No. 275 at Sta. 2 + 31.92, thence along the north side of the aforesaid alley north 79 degrees and 29 minutes east, a distance of
