

person from being registered, or who, by coercion, threats of bodily injury or intimidation, prevents or attempts to prevent any person from being registered or from changing his political enrollment in accordance with the provisions of this act, or who gives, or promises or offers to give, any gift or reward in money or, goods to any person to enroll in a particular party or to change his political enrollment, shall be guilty of a misdemeanor, and, upon conviction thereof, shall be sentenced to pay a fine not exceeding one thousand dollars (\$1000), and to undergo an imprisonment of not less than three (3) months nor more than five (5) years.

AN ACT

HB 1168

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 7.4203 acres, more or less, of land situate at Thompsettown, Juniata County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized, on behalf of the Commonwealth of Pennsylvania, to sell to the borough of Thompsettown to be used for public park or municipal purposes or industrial development or other public uses, as determined by the borough council, for a consideration of one dollar (\$1), the following described parcel of land together with all improvements thereon, situate at Thompsettown, Juniata County, Commonwealth of Pennsylvania:

All that certain parcel of land:

Beginning at a stake on the northern side of a 15 foot wide alley which point is 25 feet on a line having a bearing of north 79 degrees and 29 minutes east from the center line of State Highway Legislative Route No. 275 at Sta. 2 + 31.92, thence along the north side of the aforesaid alley north 79 degrees and 29 minutes east, a distance of

658.92 feet to a stake, thence along lands now or late of Mabel Ward Sausman north 8 degrees 36 minutes and 30 seconds west, a distance of 475.26 feet to a stake, thence along lands now or late of Katherine Kepler south 79 degrees and 29 minutes west, a distance of 715.30 feet to a stake on the eastern edge of the right-of-way of State Highway Legislative Route 275, thence along the aforesaid right-of-way line in a southerly direction on a curve to the right having a radius of 3299.17 feet, a chord distance of 476.74 feet and a chord bearing of south 15 degrees and 24 minutes east, a distance of 477.13 feet to a stake on the northern side of said 15 foot wide alley the point of beginning. Containing 7.4203 acres and being made up of the following tracts and quitclaim acquisitions:

Tract No. 1. Beginning at a concrete monument, said monument being offset on a course north 10 degrees and 31 minutes west a distance of 231.30 feet from Sta. 844 + 82.68 on State Highway Route No. 31 (US Route No. 22) and being located on the northeast corner of Church Street and a 15 foot alley, thence along the easterly line of Church Street north 10 degrees and 31 minutes west, a distance of 300 feet to a concrete monument, said monument being a point on line of property now or late of A. G. Haldeman, thence along the property of A. G. Haldeman, the following courses and distances: north 79 degrees and 29 minutes east, a distance of 100 feet to a concrete monument south 10 degrees and 31 minutes east, a distance of 300 feet to a concrete monument, said monument being a point on line of a 15 foot wide alley, thence along the northerly line of said alley south 79 degrees and 29 minutes west, a distance of 100 feet to a concrete monument, the point of beginning. Containing 0.6887 acres more or less and all that being the same tract of land acquired by the Pennsylvania Department of Highways from Bryant W. Pontius on November 16, 1931 and recorded in Juniata County Deed Book, Volume 62, page 532 on March 29, 1932.

Tract No. 2. Beginning at a point, said point being the southeast corner of Tract No. 1 described above, thence along the property of the Commonwealth of Pennsylvania north 10 degrees and 31 minutes west, a distance of 300 feet to a point, thence along the property of the Commonwealth of Pennsylvania south 79 degrees and 29 minutes west, a distance of 100 feet to a point, thence along the eastern edge of a 40 foot wide street known as Church Street north 10 degrees and 31 minutes west, a distance of 150 feet to an iron pin, thence along lands now, or late, of Katherine Kepler the following courses and distances: north 79 degrees and 29 minutes east, a distance of 300 feet to an iron pin, south 10 degrees and 31 minutes east, a distance of 450 feet to an

iron pin on the northern line of a 15 foot wide alley, thence along the aforesaid 15 foot wide alley south 79 degrees and 29 minutes west, a distance of 200 feet to the point of beginning. Containing 2.4105 acres more or less and all that being the same tract of land acquired by the Pennsylvania Department of Highways from A. G. Haldeman on February 8, 1933 and recorded in Juniata County Deed Book, Volume 63, page 273 on May 15, 1933.

Tract No. 3. Beginning at a point on the northern side of a 15 foot wide alley, which point is 65.48 feet on a line having a bearing of north 79 degrees and 29 minutes east from the center line of State Highway Legislative Route No. 275 at Sta. 2 + 31.92, thence north 79 degrees and 29 minutes east, a distance of 199.44 feet to a concrete monument, thence along lands of the Commonwealth of Pennsylvania north 10 degrees and 31 minutes west, a distance of 450 feet to a concrete monument, thence along same north 79 degrees and 29 minutes east, a distance of 300 feet to a concrete monument, thence along same south 10 degrees and 31 minutes east, a distance of 450 feet to a concrete monument on the northern side of the aforesaid 15 foot wide alley, thence along the northern side of the said 15 foot wide alley north 79 degrees and 29 minutes east, a distance of 119 feet to a stake, thence along lands now, or late, of Mabel Ward Sausman north 8 degrees 36 minutes and 30 seconds west, a distance of 475.26 feet to a stake, thence along other lands of Katherine Kepler south 79 degrees and 29 minutes west, a distance of 622.93 feet to a stake, thence along lands of Thompsontown Volunteer Fire Company south 9 degrees and 9 minutes east, a distance of 475.14 feet to a point on the northern side of the aforesaid 15 foot wide alley, the place of beginning. Containing 3.6691 acres more or less. With the exception and exclusion of that portion of the tract bounded and described as follows:

Beginning at an oak stake, said oak stake being located on the northern side of a 15 foot wide alley and also 564.92 feet on a line having a bearing of north 79 degrees and 29 minutes east from the center line of State Highway Legislative Route No. 275 at Sta. 2 + 31.92, thence along the eastern property line of the Commonwealth of Pennsylvania north 10 degrees and 31 minutes west, a distance of 450 feet to an oak stake, thence north 79 degrees and 29 minutes east, a distance of 134 feet to an oak stake on line of lands now, or late, of Mabel Ward Sausman, thence south 8 degrees 36 minutes and 30 seconds east, a distance of 450.25 feet to an oak stake on the northern side of the aforementioned 15 foot wide alley, thence along the northern side of the aforesaid alley south 79 degrees and 29 minutes west, a distance

of 119 feet to an oak stake, the place of beginning. Containing 1.3068 acres more or less. All that being the same tract of land containing 2.3623 acres more or less acquired by the Pennsylvania Department of Highways on August 29, 1952 from Katherine Kepler and recorded in Juniata County Deed Book, Volume 84, page 349 ¹ on August 29, 1952.

Tract No. 4. Beginning at an oak stake, said oak stake being located on the northern side of a 15 foot wide alley and also 564.92 feet on a line having a bearing of north 79 degrees and 29 minutes east from the center line of State Highway Legislative Route No. 275 at Sta. 2 + 31.92, thence along the eastern property line of the Commonwealth of Pennsylvania north 10 degrees and 31 minutes west, a distance of 450 feet to an oak stake, thence north 79 degrees and 29 minutes east, a distance of 134 feet to an oak stake on line of lands now, or late, of Mabel Ward Sausman, thence south 8 degrees 36 minutes and 30 seconds east, a distance of 450.25 feet to an oak stake on the northern side of the aforementioned 15 foot wide alley, thence along the northern side of the aforesaid alley south 79 degrees and 29 minutes west, a distance of 119 feet to an oak stake, the place of beginning. Containing 1.3068 acres more or less. All that being the same portion of land excepted and excluded from Tract No. 3, hereinbefore described, acquired by the Pennsylvania Department of Highways on August 29, 1952 from Katherine Kepler and recorded in Juniata County Deed Book, Volume 84, page 351 ¹ on August 29, 1952.

By quitclaim deed entered into on August 30, 1952 by the Pennsylvania Department of Highways and Samuel H. Swab, said Samuel H. Swab did relinquish any and all claims and options to purchase Tract No. 4 as hereinbefore described.

Tract No. 5. Beginning at a point on the northern side of a 15 foot wide alley, which point is 25 feet on line having a bearing of north 79 degrees and 29 minutes east from the center line of State Highway Legislative Route No. 275 at Sta. 2 + 31.92, thence along the north side of the aforesaid alley north 79 degrees and 29 minutes east, a distance of 40.48 feet to a stake, thence along lands of the Commonwealth of Pennsylvania north 9 degrees and 9 minutes west, a distance of 475.14 feet to a stake, thence along lands now, or late, of Katherine Kepler south 79 degrees and 29 minutes west, a distance of 92.37 feet to the eastern edge of the right-of-way of State Highway Legislative Route No. 275, thence along the eastern edge of said right-of-way in a southerly direction on a curve to the right, having a radius of 3299.17 feet, a chord distance of 476.74 feet and a chord bearing of south 15 degrees

and 24 minutes east, a distance of 477.13 feet to a point on the northern side of said 15 foot wide alley, the place of beginning. Containing 0.6520 acres more or less and all that being the same tract of land acquired by the Pennsylvania Department of Highways on September 17, 1952 from the Thompsontown Volunteer Fire Company and recorded in Juniata County Deed Book, Volume 84, page 381 ¹ on September 17, 1952.

The conveyance shall be made under and subject nevertheless to all easements, servitudes and rights of others including, but not confined to, streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipe line companies, as well as under and subject, nevertheless, to any estate or tenancies vested in third persons whether or not appearing of record for any portion of the said land or improvements erected thereon.

Section 2. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 3. All moneys received from the sale of the land herein authorized to be conveyed shall be deposited in the Motor License Fund.

Section 4. This act shall take effect immediately.

HB 1555

Providing for the dedication of the William Penn Memorial Museum and Archives Building and such activities as are pertinent to the dedication and making an appropriation for the costs of the same.

The William Penn Memorial Museum and Archives Building represents a major step forward in preserving the cultural and historical heritage of Pennsylvania and is a major building in the complex of buildings devoted to Pennsylvania State Government. Its dedication is a major event in the affairs of State Government and in the history of Pennsylvania as a Commonwealth; therefore,

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The purpose of this act is to provide for a dignified and significant dedication of the William Penn Memorial Museum and
