

Archives Building of such a scale and nature as shall be commensurate with the importance of this building in the cultural and historical functions of the Commonwealth.

Section 2. The sum of ten thousand dollars (\$10,000), or so much thereof as may be necessary, is hereby appropriated to the Pennsylvania Historical and Museum Commission to defray the costs of invitations, necessary printed materials, State functions, and other incidental expenses associated with the dedication of the William Penn Memorial Museum and Archives Building.

Section 3. This act shall take effect immediately.

AN ACT

SB 130

Amending the act of June 1, 1956 (P. L. 1944), entitled "An act providing a permanent allocation of a part of the fuels and liquids fuels tax proceeds to cities, boroughs, incorporated towns and townships, for their road, street and bridge purposes; conferring powers and imposing duties on local officers and the Department of Highways; and making an appropriation out of the Motor License Fund; and repealing existing legislation," requiring the payment over of all moneys allocated to cities, boroughs, towns and townships on the first day of April of each year.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Clause (3) of section 4, act of June 1, 1956 (P. L. 1944), entitled "An act providing a permanent allocation of a part of the fuels and liquids fuels tax proceeds to cities, boroughs, incorporated towns and townships, for their road, street and bridge purposes; conferring powers and imposing duties on local officers and the Department of Highways; and making an appropriation out of the Motor License Fund; and repealing existing legislation," is amended to read:

Section 4. The money hereby appropriated to municipalities shall be paid to the municipalities in accordance with the following formula and subject to the provisions of this act:

* * *

(3) The moneys allocated in clause (1) shall be paid over, in the manner provided by law, by the Department of Highways to the respective

cities, boroughs, towns and townships, on the first days of July and December, 1956, and the first [days] day of April [and October] of each subsequent year.

Section 2. This act shall take effect January 1, 1967.

AN ACT

SB 235

Amending the act of June 1, 1959 (P. L. 350), entitled "An act relating to the retirement of public school employes; amending, revising, consolidating and changing the laws relating thereto," extending credit for certain military service to school employes who were not contributors prior to serving in the armed forces of the United States upon certain conditions.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 206, act of June 1, 1959 (P. L. 350), known as the "Public School Employes' Retirement Code of 1959," is amended by adding at the end thereof, a new subsection to read:

Section 206. Credit for Military Service.—

* * *

(6) Any school employe who is a contributor and who served in the armed forces of the United States subsequent to September 1, 1940, and who was not a school employe prior to such period of military service and who commenced teaching within one (1) year from date of release from active duty or completion of pre-teaching education which had been interrupted by his induction into the armed forces, shall upon compliance with the provisions of article V. section 505, subsection (2), be entitled to have full credit for each year or fraction thereof not to exceed five (5) years of the service in the armed forces of the United States upon his payment to the fund of back contributions according to the provisions of article III. section 302, subsection (4.1).

Section 2. Subsection (4.1) of section 302 of the act added August 4, 1959 (P. L. 599), is amended to read:
