of any project under the provisions of this act shall preclude any further reimbursement from State funds for the project.

Section 62. Section 2606 of the act is amended to read:

Section 2606. Reports of Condition of Fund.—The State Treasurer shall report to the State [Council] <u>Board</u> of Education, at such times as the [council] <u>board</u> requests, the conditions of said fund, and shall in his annual report make an itemized statement of the receipts, disbursements, and amount on hand of said school fund and its incomes. The State [Council] <u>Board</u> of Education shall annually make to the Governor and to the Auditor General a complete detailed report of the condition of said fund, including its receipts, expenditures and investments.

Section 63. This act shall take effect immediately.

AN ACT

SB 854

Amending the act of December 22, 1951 (P. L. 1726), entitled "An act relating to the loyalty to the United States and the Commonwealth of Pennsylvania of public officers and employes, including teachers and other employes of the public school system, and officers and employes of State-aided institutions of learning; requiring oaths or affirmations by applicants for public office or employment and by present appointed officers and employes; prohibiting appointment or employment and requiring discharges after hearing in certain cases; imposing conditions on the payment of appropriations to State-aided institutions of learning; requiring statements under oath or affirmation of candidates for elective public offices; and imposing duties on State and local appointing authorities and certain other State officers," excluding from the provisions of the act certain teachers who have declarations of intent to secure United States citizenship.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (c) of section 15, act of December 22, 1951 (P. L. 1726), known as the "Pennsylvania Loyalty Act," added September 1, 1961 (P. L. 1149), is amended to read:

Section 15. Effect and Applicability of Act. -- \* \* \*

(c) The provisions of this act shall not apply to teachers in the State colleges, who are citizens or subjects of the foreign governments and whose appointments to these positions shall be temporary, and shall not

extend for a period of more than two (2) years, or who have duly sworn declarations of intent to secure United States citizenship in which case their appointments may extend beyond such two (2) year period, but not for a period to exceed four (4) years and have been approved by the Superintendent of Public Instruction.

Section 2. This act shall take effect immediately.

## AN ACT

SB 995

Amending the act of March 10, 1949 (P. L. 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," further defining first class school supplies and further providing for the purchase thereof.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 805, act of March 10, 1949 (P. L. 30), known as the "Public School Code of 1949," amended September 19, 1961 (P. L. 1484), is amended to read:

Section 805. Classes of School Supplies; Purchasing Agent.—School supplies shall be divided into two classes. The first class shall include school desks, chairs, furniture, typewriters and [school apparatus] other fixed and movable equipment for cafeterias, kitchens, science rooms, planetaria and gymnasiums. The second class shall include all other supplies, except maps, music, globes, charts, educational films, filmstrips, prepared transparencies and slides, pre-recorded magnetic tapes and disc recordings, and textbooks necessary for school use, not included in the first class. The board of school directors in any district may authorize or appoint the secretary of the board or other executive as purchasing agent for the district, with authority to purchase supplies of either class costing less than seven hundred fifty dollars (\$750).

Section 2. Section 806 of the act, amended June 8, 1961 (P. L. 277), is amended to read:
