Authorizing the Pennsylvania Historical and Museum Commission to acquire by gift on behalf of the Commonwealth certain land located in Upper Augusta Township, Northumberland County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Pennsylvania Historical and Museum Commission is hereby authorized and empowered to acquire by gift on behalf of the Commonwealth of Pennsylvania the hereinafter described tract or parcel of land situate in the Township of Upper Augusta, County of Northumberland, Pennsylvania, bounded and described as follows:

Beginning at a stake set for a corner on the eastern line of Memorial Drive, said stake being south 33 degrees 9 minutes west 256.15 feet, measured along the eastern line of Memorial Drive from the point of intersection of the south line of Shikellamy Avenue, extended, with the eastern line of Memorial Drive, thence along land of William H. Druckemiller and Dorothy H. Gass, of which the land herein described is a part, south 16 degrees 46 minutes east 254.3 feet to a stake, thence along land of said William H. Druckemiller and Dorothy H. Gass, north 73 degrees 23 minutes west 301.05 feet to a stake on the eastern line of aforesaid Memorial Drive, thence along the eastern line of said Memorial Drive north 34 degrees 28 minutes east 155 feet to a stake, thence along the eastern line of said Memorial Drive north 33 degrees 9 minutes east 190 feet to the place of beginning, it being a vacant parcel of land containing in area 1.172 acres, the same being a part of land which was conveyed by Helen L. Druckemiller to William H. Druckemiller and Dorothy H. Gass on November 29, 1961, as recorded in Deed Book 414 at page 293 in the office of the Recorder of Deeds in Northumberland County;

Located on the above described tract of land is a spring of water commonly known as Bloody Spring from the fact that a Pennsylvania soldier from the garrison of nearby Fort Augusta was killed there by the Indians on August 29, 1756.

Section 2. Title to the property shall be taken in the name of the Commonwealth of Pennsylvania and before its acceptance shall be approved by the Department of Justice.

Section 3. Upon acceptance of the title, the Pennsylvania Historical and Museum Commission shall be given full control, management and

supervision thereof, and shall have the power to adopt and carry into effect plans for the improvement and maintenance thereof and to make and enforce rules and regulations for the preservation of the property and the visitation thereof by the public.

Section 4. This act shall take effect immediately.

Amending the act of July 8, 1957 (P. L. 579), entitled "An act establishing minimum compensation and increments for members of the faculty and administration of the Thaddeus Stevens Trade School, and imposing duties on the Board of Trustees of such school and the Superintendent of Public Instruction," providing leave of absence with pay for faculty members and the superintendent of the school and increasing the minimum salary and annual increments of faculty members.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The title, act of July 8, 1957 (P. L. 579), entitled "An act establishing minimum compensation and increments for members of the faculty and administration of the Thaddeus Stevens Trade School, and imposing duties on the Board of Trustees of such school and the Superintendent of Public Instruction," is amended to read:

Establishing minimum compensation and increments for members of the faculty and administration of the Thaddeus Stevens Trade School, providing leave of absence with pay for faculty members and the superintendent of the school and imposing duties on the Board of Trustees of such school and the Superintendent of Public Instruction.

Section 2. Clauses (1) and (2) of section 2 of the act, amended July 18, 1961 (P. L. 787), are amended to read:

Section 2. Each person heretofore or 'hereafter appointed to a position as a member of the faculty of the Thaddeus Stevens Trade School shall receive the following minimum salaries and yearly increments for services rendered during the regular school term or years:
