separating divided highways, which disabled vehicles may remain there for a period of thirty-six (36) hours, after which said vehicle shall be deemed to have been abandoned and peace officers shall have authority to remove it and place it in storage.

A further exception shall be made when a person operating a motor vehicle bearing plates issued to a handicapped person as prescribed in section 501.1 of this act and which motor vehicle is being operated by or for the benefit of such handicapped person shall be relieved of any liability with respect to parking for a period of ninety minutes in excess of the legal parking period permitted by local authorities except where local ordinances or police regulations prohibit parking on any highway for the purpose of creating a fire lane or where said ordinances or police regulations provide for the accommodation of heavy traffic during morning, afternoon or evening hours or where such motor vehicle is parked in such a manner as to clearly be a traffic hazard.

Penalty.—Any person violating any of the provisions of this section shall, upon summary conviction before a magistrate, be sentenced to pay a fine of not less than two dollars (\$2.00) nor more than ten dollars (\$10.00) and costs of prosecution, and, in default of the payment thereof, shall undergo imprisonment for not more than five (5) days.

SB 804

Amending the act of May 27, 1949 (P. L. 1903), entitled "An act providing for powers, responsibilities, duties and limitations of the Governor, Adjutant General, Department of Military Affairs, Pennsylvania State Armory Board, Military Reservation Commission in connection with the armed Military and Naval forces and the internal security of the Commonwealth; for the definition, organization, powers and limitations of the unorganized militia, Pennsylvania National Guard, Pennsylvania Guard, Naval Militia, Pennsylvania Naval Militia and for coordination with the government of the United States in the organization and functioning of the Pennsylvania National Guard and the National Guard of the United States apportioned the Commonwealth," providing for the award of the Pennsylvania Outstanding Aeronautical Achievement Award.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1101, act of May 27, 1949 (P. L. 1903), known as "The Military Code of 1949," is amended to read:

Section 1101. Authorized Decorations, Medals and Awards.—The following decorations, medals, ribbons, badges and awards are authorized to be presented by the Governor in the name of the Commonwealth under conditions and methods enumerated hereafter in this article.

- 1. Pennsylvania Cross for Valor.
- 2. Pennsylvania Distinguished Service Medal.
- 3. Pennsylvania Meritorious Medal.
- 4. Pennsylvania Commendation Ribbon.
- 5. State medal for Federal service during any war.
- 6. Service Ribbon and/or Medal for active State service during an emergency.
 - 7. Pennsylvania twenty year service medal.
 - 8. General Thomas J. Stewart Medal.
 - 9. Pennsylvania Outstanding Aeronautical Achievement Award.

Marksmanship Medals or Badges.

Section 2. Section 1103 of the act is amended by adding after clause (12), a new clause to read:

Section 1103. Method of Award.—The authorized decorations, medals, ribbons, badges and awards will be awarded to the following persons and under the conditions and methods specifically mentioned in this section:

* * *

(13) The Pennsylvania Outstanding Aeronautical Achievement Award shall be awarded by the Governor to members of the Pennsylvania National Guard, the US Air Force, US Army, US Navy or to the National Guard of another state for outstanding performance of duty, involving any phase of aeronautical or aerospace achievement which is of great note or importance, or establishes a record of considerable standing, and/or promotes the cause of military aviation and aerospace operations to such a degree that it generates much favorable public attention and support. This award may be made on the recommendation

of squadron, group, or higher commands within the Pennsylvania National Guard, through the Department of Military Affairs to the Governor.

HB 1522

Providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; providing for public support and capital improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- Section 1. Short Title.—This act shall be known and may be cited as the "Temple University—Commonwealth Act."
- Section 2. Legislative Findings; Declaration of Policy.—It is hereby determined and declared as a matter of legislative finding:
- (1) That the Temple College of Philadelphia was created a corporation with perpetual existence under the laws of the Commonwealth of Pennsylvania under an act of the General Assembly of the Commonwealth of Pennsylvania entitled "An act to provide for the incorporation and regulation of certain corporations," approved the twenty-ninth day of April, 1874, and its supplements, and its charter approved by the Court of Common Pleas No. 1 for the County of Philadelphia, of March Term, 1888, No. 346, on the twelfth day of May, 1888;
- (2) That the original Charter of Incorporation was amended in the Court of Common Pleas No. 1, for the County of Philadelphia on the eighth day of April, 1891 and on the twelfth day of December, 1907;
- (3) That the name of the Temple College of Philadelphia was changed to Temple University by amendment of the original Charter of Incorporation on the twelfth of December, 1907;
