

or provided for shall have all the powers of a similar local fiduciary with respect to money deposited or invested in a financial institution located in Pennsylvania and shall not be required to comply with the conditions and limitations of section 1101. For the purpose of this subsection "financial institution" shall mean a bank, a bank and trust company, a trust company, a savings and loan association, a credit union, a savings bank, a private bank and a national bank.

Section 2. This act shall take effect immediately.

AN ACT

SB 1006

Amending the act of August 22, 1953 (P. L. 1344), entitled "An act relating to marriage; and amending, revising, consolidating and changing the law relating thereto," providing that judges of the United States courts situate in Pennsylvania may solemnize marriages.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 13, act of August 22, 1953 (P. L. 1344), known as "The Marriage Law," is amended to read:

Section 13. Persons Qualified to Solemnize Marriages.—The chief justice and each justice of the Supreme Court, the president judge and each judge of the Superior Court, the president judge and each judge of the court of common pleas court, the president judge and each judge of the orphans' court, the president judge and each judge of the Allegheny County and the Philadelphia Municipal Court, judges of the District Courts of the United States for the Eastern, Middle and Western Districts of Pennsylvania and each judge of the United States Court of Appeals for the Third Circuit who is a resident of Pennsylvania, each magistrate, alderman, justice of the peace, mayor of any city, and burgess of any borough of this Commonwealth, and each minister, priest or rabbi of any regularly established church or congregation, is hereby authorized to solemnize marriages between such

persons as produce a marriage license issued by the clerk of the orphans' court.

Every religious society, religious institution or religious organization in this Commonwealth may join together in marriage such persons as are members of the said society, institution or organization, or when one of such persons is a member of such society, institution or organization, according to the rules and customs of the society, institution or organization to which either of them belong.

Section 2. This act shall take effect immediately.

AN ACT

SB 1011

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 5.56 acres, more or less, of land situate in Lower Merion Township, Montgomery County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, to sell, at private or public sale to the highest bidder, the following described tract of land, together with all improvements thereon, situate in Lower Merion Township, County of Montgomery, Commonwealth of Pennsylvania, all that certain piece or tract of land:

Beginning at a marble stone set to mark the intersection of the centerline of Montgomery Avenue 66 feet wide with the centerline of Booth Lane 40 feet wide, being also a corner of land now or late of Booth Estate, thence extending along the centerline of Booth Lane and along land now or late of the Booth Estate north 61 degrees, 39 minutes east, 796.47 feet to a marble stone, a corner of land now or late of Frederick Sylvester; thence by last mentioned land the two following courses and distances: south 28 degrees, 19 minutes east, 340.50 feet to a marble stone and south 61 degrees, 39 minutes west, 80 feet to a sand stone, a corner of land now or late of A. L. Snowden; thence by said land south 61 degrees, 48 minutes west, 576.50 feet to a marble
