

persons as produce a marriage license issued by the clerk of the orphans' court.

Every religious society, religious institution or religious organization in this Commonwealth may join together in marriage such persons as are members of the said society, institution or organization, or when one of such persons is a member of such society, institution or organization, according to the rules and customs of the society, institution or organization to which either of them belong.

Section 2. This act shall take effect immediately.

AN ACT

SB 1011

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 5.56 acres, more or less, of land situate in Lower Merion Township, Montgomery County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, to sell, at private or public sale to the highest bidder, the following described tract of land, together with all improvements thereon, situate in Lower Merion Township, County of Montgomery, Commonwealth of Pennsylvania, all that certain piece or tract of land:

Beginning at a marble stone set to mark the intersection of the centerline of Montgomery Avenue 66 feet wide with the centerline of Booth Lane 40 feet wide, being also a corner of land now or late of Booth Estate, thence extending along the centerline of Booth Lane and along land now or late of the Booth Estate north 61 degrees, 39 minutes east, 796.47 feet to a marble stone, a corner of land now or late of Frederick Sylvester; thence by last mentioned land the two following courses and distances: south 28 degrees, 19 minutes east, 340.50 feet to a marble stone and south 61 degrees, 39 minutes west, 80 feet to a sand stone, a corner of land now or late of A. L. Snowden; thence by said land south 61 degrees, 48 minutes west, 576.50 feet to a marble

stone in the middle line of said Montgomery Avenue; thence along the middle of said Montgomery Avenue the two following courses and distances: north 43 degrees, 58 ¹minutes west, 203.50 feet to an iron pin and north 59 degrees, 8 minutes west, 166.10 feet to the point of beginning.

Containing 5.561 acres, together with the improvements erected thereon, and being the land and improvements conveyed to Commonwealth of Pennsylvania by deed of William Park and Dorothy P. Park, his wife, dated December 26, 1952, and recorded in Montgomery County Deed Book Volume 2337 at page 99 on December 31, 1952.

The conveyance shall be made under and subject, nevertheless, to all easements, servitudes and rights of others, including but not confined to streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipe line companies as well as under and subject, nevertheless, to any estate or tenancies vested in third persons, whether or not appearing of record, for any portion of the said land or improvements erected thereon.

Section 2. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 3. All moneys received from the sale of the land herein authorized to be conveyed shall be deposited in the Motor License Fund.

Section 4. This act shall take effect immediately.

SB 1117

Amending the act of March 2, 1956 (P. L. 1206), entitled, as amended, "An act relating to and defining the practice of podiatry; conferring powers and imposing duties on the State Board of Podiatry Examiners and the Department of State; requiring licensure; providing for the granting, cancellation, suspension and revocation of licenses; preserving the rights of existing licenses; providing for the promulgation of rules and regulations; transfer of jurisdiction and records to the board; regulation of schools of chiropody and podiatry; reciprocity; and providing penalties, and remedies," changing the definition of podiatry.
