## AN ACT

SB 50

Amending the act of June 23, 1931 (P. L. 932), entitled "An act relating to cities of the third class; and amending, revising, and consolidating the law relating thereto," authorizing cities to increase allowances paid out of the firemen's pension fund after the termination of the services of the contributors.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The act of June 23, 1931 (P. L. 932), known as "The Third Class City Code," reenacted and amended June 28, 1951 (P. L. 662), is amended by adding, after section 4322, a new section to read:

Section 4322.1. Increase of Allowances After Retirement.—Any city may, at any time, at its discretion, upon the recommendation of the persons having custody and management of the firemen's pension fund, increase the allowances of persons receiving allowances of any kind from the fund by reason of and after the termination of the services of any member of the fund. Such increases shall be in conformity with a uniform scale, but the total of any such allowances shall not at any time exceed one-half of the current salary being paid firemen of the highest pay grade.

## AN ACT

SB 308

Amending the act of July 28, 1953 (P. L. 723), entitled "An act relating to counties of the second class; amending, revising, consolidating and changing the laws relating thereto," increasing the annual salaries of certain county officers.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1810, act of July 28, 1953 (P. L. 723), known as the "Second Class County Code," amended October 26, 1959 (P. L. 1382), is amended to read:

Section 1810. Salaries of County Officers.—The annual salaries of the following county officers shall be as follows:

The sheriff, [fifteen thousand five hundred dollars (\$15,500)] <u>eighteen</u> thousand six hundred dollars (\$18,600).

The prothonotary, [fifteen thousand five hundred dollars (\$15,500)] cighteen thousand six hundred dollars (\$18,600).

The recorder of deeds, [fifteen thousand five hundred dollars (\$15,500)] eighteen thousand six hundred dollars (\$18,600).

The register of wills and clerk of the orphans' court, [eight thousand five hundred dollars (\$8,500)] ten thousand two hundred dollars (\$10,-200).

The clerk of the court, [fifteen thousand five hundred dollars (\$15,500)] eighteen thousand six hundred dollars (\$18,600).

The treasurer, [fifteen thousand five hundred dollars (\$15,500)] eighteen thousand six hundred dollars (\$18,600).

The controller, [fifteen thousand five hundred dollars (\$15,500)] eighteen thousand six hundred dollars (\$18,600).

The coroner, [fifteen thousand five hundred dollars (\$15,500)] eighteen thousand six hundred dollars (\$18,600).

The district attorney, [seventeen thousand dollars (\$17,000)] twenty thousand four hundred dollars (\$20,400).

The chairman of the county commissioners, [twenty-one thousand five hundred dollars (\$21,500);] twenty-five thousand eight hundred dollars (\$25,800); the other county commissioners, [eighteen thousand five hundred dollars (\$18,500)] twenty-two thousand two hundred dollars (\$22,200), each.

Two elective jury commissioners, [eleven thousand dollars (\$11,000)] thirteen thousand two hundred dollars (\$13,200).

Section 2. The provisions of this act relating to the salaries of county officers shall become effective and applicable to all of the pertinent county officers who shall begin a term of office on or after the first Monday of January, 1966.
