[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That the said Elijah Phillips shall receive and hold the moneys arising from the said sale, for the use and benefit of the persons who shall severally be entitled to the same, or any part thereof, by the said last will and testament of the said Samuel Harvey, deceased.

CHAPTER MDCCLXIII.

AN ACT TO PROVIDE FOR THE BETTER COLLECTION OF THE REVENUE ARISING FROM TAVERN LICENSES.

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the clerks of the several courts of quarter sessions within this commonwealth, first having obtained from the secretary of the commonwealth a competent number of licenses, shall, within ten days next after each term in their respective counties, transmit or deliver to the treasurer of said counties a number of licenses, equal to the number of the judges of said courts, together with a list of the names of the persons so recommended, taking receipts for said licenses, and persons to whom recommendations shall have been granted by also transmit a list of said names to the secretary of the commonwealth, and a duplicate thereof to the register general.

[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That the county treasurers, on re-

ceiving said licenses, shall deliver them to the persons recommended, on their application and payment therefor, and report quarterly to the judges of the court the names of the persons who have been delinquent in taking out such licenses, whereupon the judges shall direct indictments to be preferred before the grand jury against the said delinquents, for keeping tippling-houses, if it appears by the report of the constables, or other sufficient testimony, they continue to sell spirituous liquors by small measure.

[Section III.] (Section III, P. L.) And be it further enacted by the authority aforesaid, That the county treasurers shall receive five per cent., for their services in collecting and paying said license money, and shall settle their accounts in the same manner as for state taxes.

[Section IV.] (Section IV, P. L.) And be it further enacted by the authority aforesaid, That the clerks of the several courts of quarter sessions shall receive forty cents, and no more, [from any person,] for reading a petition or application for license, and seventy-five cents, and no more, for issuing every recommendation for the same, which shall be in full for all fees to the said clerks or courts, respectively, for their services.

[Section V.] (Section V, P. L.) And be it further enacted by the authority aforesaid, That so much of every act or acts of this commonwealth, as are supplied by or are contrary to the provisions in this act contained, shall be, and they are hereby repealed and made null and void.

CHAPTER MDCCLXIV.

AN ACT FOR GRANTING A FURTHER SUM OF MONEY FOR OPENING AND IMPROVING THE ROAD FROM WILKES-BARRE TO WYALUSING.
