AN ACT

To fix the number of Representatives in the General Assembly of the State; and to apportion the State into representative districts, as provided by the Constitution.

Section 1. Be it enacted, &c., That until the next decennial United States census and the apportionment be made thereon by law, the House of Representatives shall consist of two hundred and nine members, and shall be apportioned as follows, namely—

House of Representatives to consist of 209 members.

The city of Philadelphia shall elect forty members; and the said city shall be divided into twenty-one districts, as follows:

City of Philadelphia.

The first, second, and thirty-ninth wards shall constitute the first district, and elect three members.

The twenty-sixth, thirty-sixth, and forty-eighth wards shall constitute the second district, and elect three members.

AN ACT

To fix the number of Senators in the General Assembly of the State; to apportion the State into senatorial districts as provided by the Constitution; and to regulate the election of, and the terms of office of, the present and future elected Senators.

Fifty senatorial  
districts.

Section 1. Be it enacted, &c., That until the next United States decennial census is taken and an apportionment made thereon, the Senate shall consist of fifty members, and the State is hereby apportioned into fifty senatorial districts, each of which shall be known by the number herein attached thereto, and shall each be entitled to elect one Senator, as follows, to wit:

Districts.  
First.

First District. The first, second, twenty-sixth, thirty-ninth, and forty-eighth wards of the city of Philadelphia.

Second.

Second District. The twenty-first, twenty-eighth, thirty-seventh, thirty-eighth, and forty-third wards of the city of Philadelphia.
