Fourteen. In [Washington] Canton Township, Washington County.—One plot of land, containing .551 acres, located in [the city of Washington] Canton Township, Washington County, facing Oakland and Ohio Avenues.

Section 2. Section one of the said act, is hereby further amended by adding immediately after paragraph Nineteen, paragraphs to be known as Twenty, Twentyone and Twenty-two, and to read as follows:

Twenty. In St. Marys, Elk County.—One plot of land containing 0.3903 acres located in St. Marys Borough, facing Atlantic Street on the North side.

Twenty-one. In Coudersport, Potter County.—One plot of land containing 0.6615 acres, located in Coudersport Borough, facing Locust Street on the North side and Vine Street on the West side.

Twenty-two. In Upper Providence Township, Delaware County.—One plot of land containing 0.839 acres, located on and facing Providence Road (Legislative Route 144) on the West side, approximately one and one-half (1½) miles North of Media Borough.

Section 3. The provisions of this act shall become effective immediately upon final enactment.

## AN ACT

To amend clause (g) of section two hundred four of the act, approved the twenty-second day of May, one thousand nine hundred and thirty-three (Pamphlet Laws, eight hundred fifty-three), entitled "An act relating to taxation; designating the subjects, property and persons subject to and exempt from taxation for all local purposes; providing for and regulating the assessment and valuation of persons, property and subjects of taxation for county purposes, and for the use of those municipal and quasi-municipal corporations which levy their taxes on county assessments and valuations; amending, revising and consolidating the law relating thereto; and repealing existing laws," by providing that the exemption from local taxation afforded to certain public property shall not extend to property otherwise taxable which is owned or held by an agency of the Government of the United States.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Clause (g) of section two hundred four of the act, approved the twenty-second day of May, one thousand nine hundred and thirty-three (Pamphlet Laws, eight hundred fifty-three), entitled "An act relating to taxation; designating the subjects, property
