## AN ACT

Amending the act of January twenty-one, one thousand nine hundred forty-seven (Pamphlet Laws 3), entitled "An act relating to officers and employes of the General Assembly; fixing the number, qualifications, compensation, mileage and duties of the officers and employes of the Senate and of the House of Representatives; providing for their election or appointment, term of office, or of service, removal, and manner of filling vacancies; and making appropriations to the Senate, House of Representatives and Legislative Reference Bureau," changing the title of and compensation of certain Senate and House employes; providing for the appointment of additional employes therein; and making appropriations.

General Assembly.

Section 2, act of January 21, 1.947, P. L. 8, amended April 7, 1955, P. L. 31, further amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section two of the act of January twentyone, one thousand nine hundred forty-seven (Pamphlet Laws 3), entitled "An act relating to officers and employes of the General Assembly; fixing the number, qualifications, compensation, mileage and duties of the officers and employes of the Senate and of the IIouse of Representatives; providing for their election or appointment, term of office, or of service, removal, and manner of filling vacancies; and making appropriations to the Senate, House of Representatives and Legislative Reference Bureau,' amended April seven, one thousand nine hundred fifty-five (Pamphlet Laws 31), is amended to read :

Section 2. The following officers and employes of the Senate shall be appointed by the President of the Senate, to serve at his pleasure and receive the compensation and perform the duties herein specified:
(1) Two clerks to the President at an annual salary of [three thousand three hundred dollars (\$3300)] three thousand six hundred sixty-six dollars (\$3666) each;
(2) One secretary to the President at an annual salary of [four thousand one hundred dollars (\$4100)] four thousand five hundred dollars (\$4500);
(3) One administrative assistant to the President at an annual salary of [five thousand dollars (\$5000)] five thousand five hundred dollars (\$5500);
(4) One President's page at a per diem compensation of ten dollars (\$10).

Section 2. Sections three, four, five, six, seven and eight of the act, amended August 21, 1953 (P. L. 1262), and amended, in part, April 7, 1955 (P. L. 31), are amended to read:

Section 3. The following officers and employes of the Senate shall be appointed by the President pro tempore of the Senate to serve at his pleasure and receive the compensation and perform the duties herein specified:
(1) One secretary to the President pro tempore at an annual salary of [four thousand one hundred dollars (\$4100)] four thousand five hundred dollars (\$4500);
(1.1) Two clerks to the President pro tempore at an annual salary of [three thousand three hundred dollars (\$3300)] three thousand six hundred sixty-six dollars (\$3666) each;
(1.2) One administrative assistant to the President pro tempore at an annual salary of [five thousand dollars ( $\$ 5000$ )] five thousand five hundred dollars (\$5500);
(2) One messenger to the President pro tempore at a per diem compensation of ten dollars ( $\$ 10$ );
(3) One chaplain at a per diem compensation of eight dollars (\$8);
(4) One journal clerk at a compensation of two thou. sand two hundred dollars ( $\$ 2200$ ) for each regular session, plus [eleven dollars ( $\$ 11$ )] twelve dollars ( $\$ 12$ ) for each day following the fifteenth day of June of any regular session which extends beyond the fifteenth day of June, and [eleven dollars (\$11)] twelve dollars (\$12) per diem for each special or extraordinary session;
(5) One assistant journal clerk at a compensation of one thousand nine hundred eighty dollars (\$1980) for each regular session, plus eleven dollars (\$11) for each day following the fifteenth day of June of any regular session which extends beyond the fifteenth day of June, and eleven dollars ( $\$ 11$ ) per diem for each special or extraordinary session;
(6) One reading clerk at a compensation of two thousand four hundred seventy-five dollars ( $\$ 2475$ ) for each regular session, plus eleven dollars ( $\$ 11$ ) for each day following the fifteenth day of June of any regular session which extends beyond the fifteenth day of June, and thirteen dollars and fifty cents ( $\$ 13.50$ ) per diem for each special or extraordinary session;
(7) One message clerk at a per diem compensation of [eleven dollars (\$11)] fifteen dollars (\$15);
(8) One postmaster at a per diem compensation of nine dollars ( $\$ 9$ );
(9) One assistant postmaster at a per diem compensation of eight dollars (\$8);

(4) One messenger to the Senate librarian at an annual salary of [two thousand three hundred ten dollars ( $\$ 2310)]$ two thousand six hundred fifty dollars (\$2650);

Section 7. The following employes of the Senate shall be appointed by the Majority Leader of the Senate who, for the purpose of this act, shall be deemed an officer of the Senate, to serve at his pleasure and receive the compensation and perform the duties herein specified:
(1) One Secretary to the Majority Leader at an annual salary of [four thousand one hundred dollars ( $\$ 4100$ )] four thousand five hundred dollars (\$4500);
(2) One administrative assistant to the Majority Leader at an annual salary of [five thousand dollars ( $\$ 5000$ )] five thousand five hundred dollars ( $\$ 5500$ );
(3) One legislative clerk to the majority leader at [a per diem compensation of fifteen dollars (\$15)] an annual salary of three thousand thirty-six dollars (\$3036).

Section 8. The following employes of the Senate shall be appointed by the Minority Leader of the Senate who, for the purpose of this act, shall be deemed an officer of the Senate, to serve at his pleasure and receive the compensation and perform the duties herein specified:
(1) One secretary to the Minority Leader at an annual salary of [four thousand one hundred dollars (\$4100)] four thousand five hundred dollars (\$4500);
(2) One administrative assistant to the Minority Leader at an annual salary of [five thousand dollaws ( $\$ 5000$ )] five thousand five hundred dollars (\$5500);
(3) One legislative clerk to the Minority Leader at [a per diem compensation of fifteen dollars (\$15)] an annual salary of three thousand thirty-six dollars (\$3036).

Section 3. Clauses (4), (7), (8), (11) and (13) of section twenty-one of the act; clause (4) amended September twenty-eight, one thousand nine hundred fifty-one (Pamphlet Laws 1565), and clauses (7), (8), (11) and (13) amended February eleven, one thousard nine hundred forty-nine (Pamphlet Laws 4), are amended to read:

Section 21. The House of Representatives shall, iramediately upon the final enactnent of this act, and in each odd-numbered year thereafter, at the beginning of each regular biennial session of the General Assembly elect, in addition to the Speaker as provided for by the Constitution, the following officers and employes, who shall serve for two years or until their successors are elected and have qualified, unless sooner removed by a majority vote of all of the Members of the House of Representatives during any regular biennial, special or extraordinary session of the General Assembly, and who shall receive the compensation and perform the duties herein specified:
(4) One Journal clerk at a compensation of two thousand two hundred dollars ( $\$ 2200$ ) for each regular session, plus [eleven dollars (\$11)] twelve dollars (\$12) for each day following the fifteenth day of June of any regular session which extends beyond the fifteenth day of June, and [eleven dollars (\$11)] twelve dollars (\$12) per diem for each special or extraordinary session;
(7) One message clerk at a per diem compensation of [twelve dollars (\$12)] fifteen dollars (\$15);
(8) Three postmasters [at] two of whom shall receive a per diem compensation of eight dollars (\$8) each, and one of whom who shall be named by the chief clerk

(2) One stenographer at [a per diem compensation of eight dollars (\$8)] an annual salary of three thousand six hundred sixty-six dollars (\$3666);
(3) One clerk at an annual salary of [three thousand three hundred dollars ( $\$ 3300$ )] three thousand six hundred sixty-six dollars (\$3666).

Section 25. The following employes of the House of Representatives shall be appointed by the Majority Leader who, for the purposes of this act, shall be deemed an officer of the Ilouse of Representatives, to serve at his pleasure and receive the compensation and perform the duties herein specified:
(1) One secretary at an annual salary of [four thousand one hundred dollars (\$4100)] four thousand five hundred dollars (\$4500);
(2) One administrative assistant at an annual salary of [five thousand dollars ( $\$ 5000$ )] five thousand five hundred dollars (\$5500);

Section 26. The following employes of the House of Representatives shall be appointed by the Minority Leader who, for the purposes of this act, shall be deemed an officer of the House of Representatives, to serve at his pleasure and receive the compensation and perform the duties herein specified:
(1) One secretary at an annual salary of [four thousand one hundred dollars (\$4100)] four thousand five hundred dollars (\$4500);
(2) One administrative assistant at an annual salary of [five thousand dollars (\$5000)] five thousand five hundred dollars (\$5500);

Section 5. The following sums, or as much thereof as may be necessary, are hereby appropriated from the General Fund to the Ilouse of Representatives of the General Assembly. Said sums shall be in addition to any sums heretofore appropriated to the House of Representatives for any of said purposes.

## To the House of Representatives

For the payment of contingent expenses of the chief clerk of the House of Representatives for the legislative session of one thousand nine hundred fifty-five, the sum of seven thousand five hundred dollars ( $\$ 7500$ ).
Section 6. This act shall take effect immediately.
