•*LVII. Appropriations for Community Nursing Services.*—*To appropriate money annually towards any nonprofit associations or corporations which provide community nursing services, in recognition of their services in the control of communicable disease, the immunization of children, the operation of child health centers (Well-Baby Clinics), instructive visits to mothers of new babies beginning in the prenatal period and family health guidance, including nutrition, detection and correction of defects.*

Act effective immediately.

Section 2. This act shall take effect immediately.

AN ACT

Amending the act of June 1, 1933 (P. L. 1172), entitled "An act establishing certain streets in boroughs and incorporated towns as State highways, and providing for their construction and maintenance at the expense of the Commonwealth," changing or deleting certain routes and adding certain new routes.

State highways in certain boroughs and incorporated towns.

Section 2, act of June 1, 1933, P. L. 1172, certain routes deleted or amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following routes established by section 2, act of June 1, 1933 (P. L. 1172), entitled "An act establishing certain streets in boroughs and incorporated towns as State highways, and providing for their construction and maintenance at the expense of the Commonwealth," and its amendments, are deleted as indicated or amended to read:

#### Spangler Borough

Route 11100.

[Route 11100. Beginning at the intersection of the Spangler Borough line and 12th Street; thence in a southeasterly direction over 12th Street, in Spangler Borough, to the intersection with Legislative Route 62, in Cambria County, a distance of about 0.55 of a mile.]

#### Atglen Borough

Route 15062,

Route 15062, Spur E. Beginning at a point at the intersection of [Liberty Street, Route 15063, and West Main Street, Route 15062 Spur E] Valley Avenue;

thence southerly on West Main Street to the intersection of West Main Street and Lower Valley Road, Route 15062, in the Borough of Atglen, Chester County, a distance of about [0.2530] 0.17 of a mile.

Route 15063, Extending Route 15063. Beginning at a point on the Atglen Borough-West Sadsbury Township line; thence in a westerly direction on Upper Valley Road in a southerly direction on Swan Road [and in a westerly direction on Liberty Street to an intersection with Route 215, at Liberty Street, and the Gap and Newport pike] to an intersection with Swan Road, Liberty Street and Green Street, State Highway Route 485 in the Borough of Atglen, Chester County, a distance of about [.41] 0.27 of a mile. Route 15063.

#### Pottstown Borough

Beginning at a point on the Pottstown Borough-Upper Pottsgrove Township line; thence in a southwestwardly direction on Keim Street to an intersection with Route 146, at High and Keim Streets, in the Borough of Pottstown, Montgomery County, a distance of about .65 of a mile.] Route 46005.

#### Vandergrift Borough

[Route \*LR188. Beginning at the intersection of Hancock Avenue and Longfellow Street; thence along Longfellow Street to Holland Street; thence along Holland Street to its intersection with Bryant Street, a distance of about 0.6 of a mile in Vandergrift Borough, Westmoreland County.] Route LR188.

#### Liberty and Port Vue Boroughs

Route 02259. Beginning on river road at the Liberty Borough-Lincoln Township line; thence northerly to the Port Vue Borough line; thence continuing northerly on river road to McKeesport City line, a distance of about 2.2 miles in Liberty and Port Vue Boroughs, Allegheny County. Route 02259.

#### Dayton Borough

Route 03170. Beginning at a point at the intersection of Highway Route 534, Legislative Route 03075 and Legislative Route 03095 and extending northwest over State Street in Dayton Borough, Armstrong County, a Route 03170.

#### Womelsdorf Borough

Beginning at the intersection of High Street and West Second Street (State Highway Route 382); thence eastwardly along High Street to its intersection with State Highway Route 422 at the borough line, a distance of about 0.55 of a mile in the Borough of Womelsdorf, Berks County.*

#### Penn-del Borough

Route 09173. *Route 09173. Beginning at the intersection of abandoned Route 152 and Legislative Route 281; thence in a southeasterly direction 851 feet over abandoned Route 152 to a point on the Penn-del Borough-Middletown Township line in Penn-del Borough, Bucks County, a distance of about 0.16 of a mile.*

#### Spangler Borough

Route 11112. *Route 11112. Beginning at a point on the Spangler Borough-Susquehanna Township line; thence over Fifteenth Street, Crawford Avenue and Sixteenth Street to Route 62 in the Borough \*of Spangler, Cambria County, a distance of about 0.5 of a mile.*

#### Gallitzin Borough

Route 11113. *Route 11113. Beginning at a point on Main Street at the Gallitzin Township-Gallitzin Borough line; thence over Main Street in Gallitzin Borough, a distance of about five-eighths of a mile, in Cambria County.*

#### South Coatesville Borough

Route 15244. *Route 15244. Beginning at a point on Route 15236 in South Coatesville Borough; thence in a northerly direction on Newlinville Road to a point on the South Coatesville Borough-East Fallowfield Township line in South Coatesville Borough, Chester County, a distance of about 0.30 of a mile.*

## Mill Hall Borough

*Route 18049. Beginning at the intersection of Beech Creek Avenue and Water Street (State Route 58, Spur A); thence westerly over Beech Creek Avenue to the Mill Hall Borough-Bald Eagle Township line, a distance of about 2902 feet in Mill Hall Borough, Clinton County.* Route 18049.

## Berwick Borough

*Route 19122. Beginning at a point on the East Berwick Borough-Salem Township line; thence over Fowler Avenue to the North Berwick Borough-Brier Creek Township line in Berwick Borough, Columbia County, a distance of about 0.5 of a mile.* Route 19122.

## Perryopolis Borough

*Route 26192. Beginning in Washington Square in the Borough of Perryopolis at a point of intersection with Legislative Route 26013; thence from said Washington Square running in an easterly direction over Borough Road, formerly Perry Township road 773, to an intersection with Township Road, now Borough Road 568, in the Borough of Perryopolis, Fayette County, a distance of about 0.37 of a mile.* Route 26192.

## Homer City Borough

*Route 32184. Beginning at the intersection of North Main Street (Legislative Route 68) and East Mullen Street; thence northeasterly over East Mullen Street to its intersection with Indiana Street (Legislative Route 68) in the Borough of Homer City, Indiana County, a distance of about 0.2 of a mile.* Route 32184.

## Indiana Borough

*Route 32185. Beginning at the intersection of Oakland Avenue and Eleventh Street; thence southerly over Eleventh Street to Grant Street; thence southeasterly over Grant Street to Wayne Avenue (Route 68, Traffic Route 119) in the Borough of Indiana, Indiana County, a distance of about 0.42 of a mile.* Route 32185.

## Thompsontown Borough

*Route 34067. Beginning at an intersection with U. S. Route 22; thence in a northerly direction over North Mill Street, a distance of about 1875 feet, to an intersection with State Route 275.* Route 34067.

## Dickson City and Throop Boroughs

#### Port Allegany Borough

#### Sharpsville Borough

Route 43124. *Route 43124. Beginning at the south side of Legislative Route 238, known as Ridge Avenue; thence in a southerly direction over Seventh Street in the Borough of Sharpsville to the north side of Legislative Route, Spur 43008, known as Hazen Road, a distance of about 0.1 mile.*

#### Pottstown Borough

Route 46207. *Route 46207. Beginning at a point on the lower Pottsgrove Township-Pottstown Borough line; thence in a*

#### Stoystown Borough

*Route 55166. Beginning at the intersection of Township Route 799 with Highway Street at the easterly line of Stoystown Borough; thence southwesterly over Highway Street to its intersection with Main Street (Legislative Route 849) in the Borough of Stoystown, Somerset County, a distance of .83 of a mile.* Route 55166.

#### Montrose Borough

*Route 57159. Beginning at the intersection of Legislative Route 12 and Cherry Street; thence northeasterly over Cherry Street to its intersection with Legislative Route 9 in Montrose Borough, Susquehanna County, a distance of about 0.4 of a mile.* Route 57159.

#### Warren Borough

*Route 61078. Beginning at an intersection with Route 88; thence over Laurel Street in a northerly direction a distance of about .10 of a mile to an intersection with Fourth Avenue; thence in an easterly direction over Fourth Avenue a distance of about .50 of a mile to an intersection with Route 95 in Warren Borough.* Route 61078.

*Route 62222. Beginning at a point on Legislative Route 268 about 0.7 of a mile east of the intersection with Legislative Route 62176; thence in a northerly direction along Barneys Run to an intersection with Legislative Route 113 about 1.5 miles southeast of the intersection with Legislative Route 62076 in Centerville Borough, Washington County, a distance of about 2.0 miles.* Route 62222.

#### Marianna Borough

*Route 62223, Extending Route \*\*62223. Beginning at a point on the southwest Marianna Borough-West Bethlehem Township boundary line; thence in a northeasterly parallel in part to Patterson Run to an intersection with Legislative Route 62140 all in Marianna Borough, Washington County, a distance of about 1.5 miles.* Route 62223.

## Honesdale Borough

Beginning at the intersection of Legislative Route 63029 and Bunnell's Pond Road; thence in a northeasterly direction over Bunnell's Pond Road to the intersection with Legislative Route 63125 at the Honesdale Borough line in Honesdale Borough, Wayne County, a distance of about 0.7 \*mile.*

Route 63136. *Route 63136. Beginning at the intersection of Bunnell's Pond Road and road to Berlin Center; thence in an easterly direction over road to Berlin Center to the intersection with Legislative Route 63117 at the Honesdale Borough line in Honesdale Borough, Wayne County, a distance of about 0.2 \*mile.*

## Vandergrift Borough

Route 67276. *Route 67276. Beginning at the intersection of Hancock Avenue and Bryant Street; thence northeasterly over Bryant Street to its intersection with Holland Street, a distance of about 0.5 of a mile, in Vandergrift Borough, Westmoreland County.*

Effective date. Section 3. The highways established as State highways under the provisions of this act may be taken over for construction and maintenance at any time subsequent to the final enactment of this act, when the same shall become effective, and shall be taken over not later than January 1, 1958.

Amending the act of June 22, 1931 (P. L. 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," changing or deleting certain routes and adding certain new routes.
