The recorder of deeds, [seven thousand six hundred dollars (\$7,600)] *nine thousand six hundred dollars (\$9,600)*.

The county treasurer, [six thousand four hundred dollars (\$6,400)] *eight thousand four hundred dollars (\$8,400)*.

The county controller, [eight thousand five hundred dollars (\$8,500)] *ten thousand five hundred dollars (\$10,500)*.

The county surveyor, where such office exists, one hundred ten dollars (\$110).

The county commissioners, [nine thousand two hundred fifty dollars (\$9,250)] *eleven thousand two hundred fifty dollars (\$11,250)*, each.

The jury commissioners, [one thousand two hundred dollars (\$1,200)] *one thousand four hundred dollars (\$1,400)*, each.

The district attorney, [nine thousand two hundred fifty dollars (\$9,250)] *eleven thousand two hundred fifty dollars (\$11,250)*.

Section 2. This act shall become effective and applicable to all of the pertinent county officers who shall begin a term of office on or after the first Monday of January, 1960.

AN ACT

Amending the act of June 25, 1947 (P. L. 947), entitled "An act relating to the annual salaries of certain county officers of counties of the fourth class," increasing the salaries of certain county officers.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Fourth class counties.

Section 1. Section 1, act of June 25, 1947 (P. L. 947), entitled "An act relating to the annual salaries of certain county officers of counties of the fourth class," amended October 11, 1951 (P. L. 1701), is amended to read:

Section 1, act of June 25, 1947, P. L. 947, amended October 11, 1951, P. L. 1701, further amended.

Salaries of
county officers.

Section 1. The annual salaries of the following county officers of counties of the fourth class shall be as follows:

The district attorney, [eight thousand dollars (\$8,000)] *ten thousand dollars (\$10,000)*.

The sheriff, [seven thousand three hundred dollars (\$7,300)] *nine thousand five hundred dollars (\$9,500)*.

The prothonotary, [seven thousand three hundred dollars (\$7,300)] *nine thousand three hundred dollars (\$9,300)*.

The clerk of courts, [seven thousand three hundred dollars (\$7,300)] *nine thousand three hundred dollars (\$9,300)*.

The clerk of the orphans' court (other than the register of wills acting as ex-officio of orphans' court), [five thousand six hundred dollars (\$5,600)] *seven thousand six hundred dollars (\$7,600)*.

The register of wills and ex-officio of the orphans' court, [five thousand three hundred dollars (\$5,300)] *seven thousand three hundred dollars (\$7,300)*.

The recorder of deeds, [seven thousand three hundred dollars (\$7,300)] *nine thousand three hundred dollars (\$9,300)*.

The county treasurer, [six thousand two hundred dollars (\$6,200)] *eight thousand two hundred dollars (\$8,200)*.

The county commissioners, [eight thousand dollars (\$8,000)] *ten thousand dollars (\$10,000)*, each.

The county auditors, where there is a controller, each one hundred ten dollars (\$110).

The coroner, [four thousand five hundred dollars (\$4,500)] *seven thousand dollars (\$7,000)*.

The jury commissioners, [seven hundred fifty dollars (\$750)] *nine hundred fifty dollars (\$950)*, each.

The county controller, where such office exists, or may be created, [seven thousand three hundred dollars (\$7,300)] *nine thousand three hundred dollars (\$9,300)*.

Application.

Section 2. This act shall become effective and applicable to all of the pertinent county officers who shall begin a term of office on or after the first Monday of January, 1960.
