AN ACT

Amending the act of April 9, 1929 (P. L. 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," changing and clarifying the powers and duties of the Pennsylvania Historical and Museum Commission; removing certain limitation with respect to moneys in the Historical Preservation Fund and crediting certain moneys collected by the commission to such fund.

The Administrative Code of 1929.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Clause (u), section 2801-A, act of April 9, 1929, P. L. 177, added June 14, 1947, P. L. 604, further amended.

Section 1. Clause (u) of section 2801-A, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," added June 14, 1947 (P. L. 604), is amended to read:

Section 2801-A. Pennsylvania Historical and Museum Commission.—Subject to any inconsistent provisions in this act contained, the Pennsylvania Historical and Museum Commission shall have the power and its duties shall be:

* * * * *

(u) In performing its duties under the foregoing subsections to consult and procure the advice of such [archaeological, anthropological, historical, archival or museum] experts *in archaeology, anthropology, history, historical restoration, archival management, museum work or other fields related to its activities*, as it shall deem it advisable to consult and to compensate them for such services.

Section 2802-A of the act, amended May 27, 1957, P. L. 204, further amended.

Section 2. Section 2802-A of the act, amended May 27, 1957 (P. L. 204), is amended to read:

Section 2802-A. Historical Preservation Fund.—All moneys collected by the Department of Property and Supplies from the sale of publications for the Pennsylvania Historical and Museum Commission, and all

moneys collected by the commission from fees [and] *from the sale of its publications and other sales*, shall be paid into the State Treasury through the Department of Revenue and credited to a fund to be known as the "Historical Preservation Fund," which is hereby created. [Except as hereinafter provided, all] *All* moneys in the fund from time to time are hereby appropriated to the Pennsylvania Historical and Museum Commission for the preservation, care and maintenance of the historical buildings, museums, grounds, monuments, public records and antiquities committed to its custody, for the publication and republication of matters of historical or archeological interest, and for the research and editorial work incidental thereto, and for the purchase of publications, postcards and other souvenirs of an historical nature for sale at the State Museum and at the historical properties administered by the commission, [Whenever the moneys credited to the Historical Preservation Fund during any fiscal biennium exceed the average biennial allocation for the above purposes for the two preceding fiscal bienniums, the excess shall be transferred to the General Fund] *and for any other purpose prescribed in section 2801-A of this act.*

AN ACT

Amending the act of September 8, 1959 (Act No. 330), entitled "An act amending the act of June 25, 1947 (P. L. 971), entitled 'An act relating to the annual salaries and compensation of certain county officers of counties of the eighth class,' increasing the annual salaries of certain county officers in counties of the eighth class," clarifying the effective date.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Eighth class
counties.

Section 1. Section 3, act of September 8, 1959 (Act No. 330), entitled "An act amending the act of June 25, 1947 (P. L. 971), entitled 'An act relating to the annual salaries and compensation of certain county officers of counties of the eighth class,' increasing the annual salaries of certain county officers in counties of the eighth class," is amended to read:

Section 3, act of
September 8,

330, amended.

Section 3. This act shall take effect immediately and shall be applicable to all pertinent county officers who shall begin a term of office *on or* after the first Monday of January, 1960.
