AN ACT

Amending the act of August 9, 1955 (P. L. 323), entitled "An act relating to counties of the third, fourth, fifth, sixth, seventh and eighth classes; amending, revising, consolidating and changing the laws relating thereto," authorizing appropriations of moneys to airports operated by municipality authorities.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The County Code.

Section 1. Section 2209, act of August 9, 1955 (P. L. 323), known as "The County Code," is amended to read:

Section 2209, act of August 9, 1955, P. L. 323, amended.

Section 2209. Appropriating Money to Assist Political Subdivisions and Municipality Authorities for Airports.—The county commissioners of any county may appropriate moneys to assist any city, borough, town, township or other political subdivision, or municipality airport authority, within such county or within any adjacent county to acquire, establish, operate and maintain any and all air navigation facilities.

Section 2. This act shall take effect immediately.

AN ACT

Amending the act of May 1, 1933 (P. L. 103), entitled "An act concerning townships of the second class; and amending, revising, consolidating, and changing the law relating thereto," clarifying certain duties of the supervisors, township superintendents and roadmasters.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Second Class Township Code.

Section 1. Subsection (e) of section 516, act of May 1, 1933 (P. L. 103), known as "The Second Class Township Code," reenacted and amended July 10, 1947 (P. L. 1481), is amended to read:

Section 516. Duties of Supervisors, Township Superintendents, and Roadmasters.—The township supervisors, or the supervisors acting as superintendents or roadmasters, shall—

* * * * *

(e) Employ or hire such persons, as may be necessary for the [maintenance and repair of roads and bridges, and snow removal,] *general conduct of the business of*

the township, and provide for the organization and supervision of the persons so employed, and work on the roads themselves when directed to do so by the board of supervisors. Records shall be kept, and reports made and filed, giving the names of all persons employed, including supervisors, superintendent or roadmasters, dates on which work was done, and the number of hours worked with compensation paid to each person and the capacity in which he is employed.

AN ACT

Amending the act of August 9, 1955 (P. L. 323), entitled "An act relating to counties of the third, fourth, fifth, sixth, seventh and eighth classes; amending, revising, consolidating and changing the laws relating thereto," authorizing clerks of orphans' courts to join with registers of wills for the purpose of State associations and authorizing payments by the county pertaining to their annual meetings.

The County Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Sections 440, 442 and subsection (b), section 444, act of August 9, 1955, P. L. 323, amended May 27, 1957, P. L. 206, further amended.

Section 1. Sections 440, 442 and subsection (b) of section 444, act of August 9, 1955 (P. L. 323), known as "The County Code," amended May 27, 1957 (P. L. 206), are amended to read:

Section 440. State Associations Authorized.—County officers of each county may organize for themselves a State association as follows:

(1) The county commissioners, together with the county solicitor and the chief clerk to the county commissioners.

(2) The county controllers.

(3) The sheriffs.

(4) The district attorneys.

(5) The probation officers.

(6) The registers of wills *and clerks of orphans' courts*.

(7) The prothonotaries and clerks of courts of quarter sessions.

(8) The county treasurers.

(9) The recorders of deeds.

(10) The directors of veterans' affairs.

(11) The coroners.
